4) Treasurer's Report

-Tom Anderson

GLRL Team Fees for 2021/22 Season

- \$80 per team for 16 game schedules, if less we will pro-rate.
- Have not been spending money, only expenses are regular banking expenses
- GLRL will be paying 50% of scheduling software this year then will look to share the fees across associations for scheduling software fees and ramp website fees. Approximately \$800/year in total.
- When all regions go to RAMP, there will be a cost structure to account for as set out by RAMP.
- Balance \$9500 held in trust and operating balance \$5032.35
- Date not set yet for league fees to be paid target will be November 1st
- If any new teams, will need to also pay a bond cheque. Cambridge, Chatham, and Sunderland will be required to pay \$500 bond.
- All 19 returning associations have bonds in good standing to date.

5) Substitution Rule for 2021/22 Season

The current rule is:

13. Substitutions

B) Maximum number of substitute games played per season for all skaters is 5 games and for all goalies is unlimited.

PROPOSAL: That this rule is waived for this year given the assumption that team rosters will be very tight across the league during this challenging time for player retention. There is also the issue of COVID and whether a team or a portion of their roster is impacted by a positive COVID test.

Discussion:

- It's up to the league to set the number of substitutions
- Andrea gave advice that league just needs to be careful and ensure people follow the intent of the rule as this could lead to escalations at end of year if exploited
- This change could help to deal with vaccination policies as well when traveling to other arenas. The ability to call up will help alleviate the pressure.
- Nancy recommends keeping it at 5 games per player then request an exception for those running into trouble.
- Dorchester raised that this may be more of a concern for U12A age because they are unvaccinated and will be required to quarantine which would affect more girls and potentially whole teams
- Guelph requested GLRL could just make a case-by-case evaluation when they must have someone substitute more than 5 games, and teams can apply for past 5 games to GLRL
- Tom Anderson raised the concern that there is always a wait time whether vaccinated or not which could affect teams and the game schedule
- Whitby asked if we do leave the exception rule needing approval, will they be able reply quickly to requests?

Final Decision:

Leave rule as is and will continue to monitor

• When an association has used a player for 4 times, they should report to executive and request an exemption in advance whenever possible.

Ice Availability Issues per each Association?

- Hoping to have ice scheduling information out to associations soon
- Whitby may have an issue to block 4 hours in a afternoon with the AAA weekends
- Will need 12 hours per team, 8 home games
- Kitchener, Waterloo not getting 2nd half ice right now, TBD when they will get it

- Officiating Concerns for AA & A League Games?

- Officiating numbers are down
- \circ $\;$ There will be an impact but will also have less teams across the board $\;$
- Central region believes they will be ok if 3 ice pads not booked at one time. Using funds to promote more refs to get involved.
- Southern region recruiting refs and training and planning ahead
- Western region has 66 registered refs in the region
- o 300 refs in the province which is down from 500 with 50 being level 1 officials
- Recommendation: All associations to touch base with their RICs to confirm this is a top priority.

- Funfests? What Associations are planning these?

- Ringette Ontario is allowing Funfests at the beginning of the season although tournaments are not allowed until after January
- Funfests could have impact on GLRL's priority to try and front-load the league play schedule
- Oshawa is having a funfest on November 6th. One day, 3 games.
- Mitchell planning for one in March
- Pickering is looking for December 3-5th weekend
- May reduce the 16-game schedule to 12 game schedules depending on funfest impact

7) Season Scheduling Update

- Ice Submission Form Update
 - RAMP was supposed to be released on Friday October 1st with new login and password for association presidents
 - o RAMP ran into a problem crash of email so entire system down and not receiving emails
 - \circ $\;$ Should be getting emails by noon October 5^{th}
 - Email will give username/password so ice time can be submitted
 - \circ ~ Date to submit ice by end of day October 12^{th}
 - o There is a video tutorial included in the email on how to enter
 - Suggested to put ice in for the teams you plan to host, schedule will not be created before October 24th.

 Associations would like to have ice times clumped based on A, and AA to make getting refs easier. Kevin confirmed that when submitting ice, you will be able to assign ice times to level of play. Use the comments section to identify association needs.

- U16AA & U19AA game format

- Suggestion to not have 1.5-hour games and reduce to 1-hour games just for this year to allow for better scheduling
- \circ $\,$ Many associations have already allotted for this time $\,$
- \circ $\,$ Concern that some coaches are not going to be happy about this change
- Associations that want to change:

 - Waterloo has some limits with 2-hour block
 - Overwhelming majority to keep 1.5 hours for U16AA and U19AA games

9) Other Business

- Covid Restriction Review raised by Dorchester
 - Some arenas require all people over the age of 12 to be vaccinated (players and spectators)
 - Some arenas required only spectators over the age of 12 need to be vaccinated and not players
 - Recommendation: Have Arena protocols listed on your website for people to easily find
 - Associations requiring players to be vaccinated:
 - Newmarket region requires all players must be vaccinated
 - Richmond Hill region requires all players must be vaccinated
 - Markham region requires all players must be vaccinated
 - St. Mary's arena requires all players to be vaccinated
 - London Association requires all players to be vaccinated but the arena allows entry of non-vaccinated players
- A Provincial Host
 - No A level provincial host right now
 - If they cannot find A host, will have tough decisions to make
 - Suggested dates March 17-20th
 - Usually, 6 game guarantee but may be less
 - Request for associations to talk to their executive boards and arena to consider hosting
- Regional Championships
 - Western Regional Championship is March 25-27 in London
 - Southern Regional Championship is April 15-18th
- Review of Website & Adding teams to Ramp (demonstration)

- Kevin Sweeney reviewed how to enter teams in Ramp and see the link with the website
- Associations will need support from their Webmasters and Registrar and maybe Kevin to enter teams and link together sites
- Format for naming teams is "London-U12A". If you have two teams, include the coaches initial such as "London-U12A-M"
