Must give a post-dated cheque for the full registration fee, that will be cashed if failure to finish the season. Motion carried.

- h) Michael Scott motions to give Manning players the early registration discount. 3 yes, 9 opposed.
   Sandy Pecor motions we charge Manning the same registration fee of \$400 as their home association, and waive the late fee. 17 yes, 1 opposed.
