Attachment "I"- Policy for going to Provincials Entries: Hinton Minor Hockey supports the following divisions in their efforts to participate in the provincials: Atom, Peewee, Bantam & Midget. Hockey Alberta charges an initial \$100.00 fee to all teams participating in provincial play downs. Hinton Minor Hockey Association may also charge all teams the cost of ice and referees of prior to each round of play downs. All teams must declare they will enter provincial playdowns by December 5. NO EXCEPTIONS Priority: Once provincial play downs start the priority is for those games. The team must accept one of the 2 ice times offered regardless of conflicts. This may mean not participating in a tournament or re-scheduling a league game.
