NEAHL & HMHA Updates

- Booking games has been difficult when dealing with more than one deputy governor. There is no consistency. Scheduling games has been different for every team/tier. It would be a lot easier if the scheduling was the same for the entire league.
- Hinton had some teams moved in tiering this year with Neahl. Next season while making teams maybe we should look at building the teams differently.
- There is a possibility of Hinton hosting provincials. There is an application that needs to be submitted to Hockey Alberta.

Manager Equipment

 A policy will be added to our policies and procedures manual regarding manager equipment ie: tablets. There will be a \$50 fee at the beginning of the season when tablets are handed out to managers. The \$50 to be refunded back to the managers upon return of undamaged tablet.

Tournament Structure

- Parent/guardian volunteers and refusing to volunteer. As per our policies, there is a \$25 fine to the parents/guardians who refuse to volunteer. We will look at amending this policy in the future.
- Our tournament application needs more information. Teams applying seem to have a lot of extra questions. Kyle is going to add more information.
- Towards the end of the season, we will have a meeting with the tournament coordinator to discuss possible changes to the tournament manual.
- Next season look at possibly combining the U7/U9 tournament. We need to figure out how to avoid having so many back-to-back tournaments.

Refund Policy

- Other associations charge a \$25-\$50 administration fee when refunds are issued. This is something our association should also add to our By-Laws.
- Another suggestion to add to the By-Laws is refunds from the registration date and prior to the first time the player has participated in any on-ice activity, \$200 will be nonrefundable.

Individual Team Donations

- Add to the policies that each team gets a one-time donation with a cap of \$1000.00.
