3.0 Old Business

3.1 Atom/Novice Pathway

All recommendations made by the Committee within the December 5, 2019 committee meeting were approved by the Board of Directors. Memos were sent to all MHA's by the SHA on January $10^{\rm th}$.

SHA Provincial/Carded Review Process

Edward asked the Committee to address the process of applying for provincial playoffs. Specifically, the current process allows individual team officials to apply, bypassing MHA's in many situations. This has led to teams not applying on time and missing out

on opportunities due to the disconnect with their MHA and not being aware of deadlines, etc.

The Committee discussed the following at length;

- All applications for Provincials/Carded Teams must be completed by the MHA through which the SHA provides a username and password.
- All provincial team rosters and carded team rosters would no longer require signatures to make the process more efficient and could be completed and submitted electronically.
- SHA staff will enter provincial and carded teams within the Hockey Canada Registry.

The Committee also discussed the new Modified Best of Three series that has been implemented. It has gone very well so far.

3.3 U18 AAA Male and Female

Kelly had circulated the following for the Committee prior to the meeting;

- Male and Female Development Model documents.
- Drafts of U18 AAA Male and Female League Constitution and Bylaws.
- Templates of Agreement between MHA's and U18 teams.

There were several items left to address with the Committee regarding AAA and Kelly, Blaine and Lloyd have made recommendations within the Model documents. They reviewed them as follows;

- Spring Camp Timeframe
 - : Proposal is that Spring Camps cannot start until the Tuesday following the Male Sask First Spring Tournament and the Tuesday following the Female Sask First Tournament. It also allows for all U18 and U15 League and Provincial Playoffs to be completed with no conflicts. Camps will be able to be held until June 1st.

Committee was fine with this.

- Letters of Commitment
 - : Kelly, Blain and Lloyd will be working on these in the near future however the goal is to make them identical with the exception on the male one there will be the clause that allows for the release of a player when a player returns from Junior hockey. The Letters will outline what the team expects, what the player and parent can expect, and the team/parent/player must all sign the document.

Timing of Letters of Commitment

There are three recommended times.

- : The recommendation is as follows:
 - Affiliates could be committed to within forty-eight (48) hours of the last league game in the league schedule. Affiliated players not committed to for the next season are free to attend any other teams spring/fall camp.
 - ➤ All teams must have committed to a minimum of fifteen players (male) and twelve players (female) by June 1st.
 - All team's rosters must be completed by midnight Monday of the Labour Day weekend.

Committee was fine with this.

- How many U15 players can be affiliated to AAA teams? Can U15 players attend spring and fall camps?
 - Recommendation is that U15 aged players from the previous season can attend spring camps but not fall camps.

Committee was fine with this.

: Recommendation was that each AAA team could affiliate two (2) U15 second year AA players. These players would be restricted to tengames and that would include exhibition, tournament and league and they would not be able to move up to AAA when their U15 team's season is completed.

There was significant discussion on this by the Committee. Edward asked for each committee member position on the recommendation and it was eight (8) for and four (4) against therefore the Committee was in favour.

- Two AAA Leagues - Common Constitution, Bylaws and Policies

These documents were created by Kelly, Lloyd and Blaine to have consistency between the two. The league's policies/regulations are currently being worked on.

Kelly asked the Committee members to provide any feedback to him by Wednesday, March 4, 2020.

- Update on Template Agreements between MHA and AAA Teams
 - : A template agreement for MHA's and their AAA teams was provided to the Committee. Kelly and SHA legal council Aaron Fox put together the documents. It is a template and can be amended, however the key is

that there are currently many MHA's that have nothing in Place and this can assist those MHA's at this time.

Kelly asked if there is any feedback to provide it to him Wednesday, March 4, 2020.

3.4 Age Appropriateness

Recommendation from the Committee in January was approved by the pard of Directors and sent to the membership.
