## Criteria to use in picking teams (adopted in 2013/14)

U9

(New for 2019) No Associates

#### U11

- Limit admittance to Associates with a tiering process similar to Regina. IE, AA, A, etc. (Lumsden, Moose Jaw and Prairie Storm)
  - o Continue to limit the radius to 80KM.
  - The only exception is Grand Coulee/Pense.
  - o Note that Atom will be closed to Associates for 2020/21 season

#### U13

- Limit admittance to Associates with a tiering process similar to Regina. IE, AA, A, etc. (Lumsden, Moose Jaw and Prairie Storm)
  - This will level the playing field at AA + A
  - o Continue to limit the radius to 80KM.
  - The only exception is Grand Coulee/Pense

#### U15 + U18

- No changes to the current Associates.
  - Currently our U15 and U18 AA teams are traveling greater distance. EG. U15 travels province wide, U18 travels Southern Sask.
  - Most "star" rural players would be playing AAA or AA
  - o The A teams will be traveling less than the AA teams.
- No additional Associates to play in HRI.
  - Any Associates that are wishing to join will currently be playing in a league now.
    So they will have a place to play

- U18A 1 team
- Recommend to accept

## **Notre Dame**

- U18A 1 team
- Allow them to use one overage player
- This is their seventh ranked team
- Recommend to accept

#### Weyburn

- U15A 1 team
- Recommend to accept.

### **Grand Coulee/Pense**

- U11: B- 1 team
- U13: B 1 team (Allow them to use a goalie from Rouleau)
- Recommend to accept

### **Prairie Storm**

- U11: A 2 teams, B 2 teams, C 2 teams (1 male, 1 female)
- U13: A − 2 teams, B − 2 teams, C − 1 team
- U15: A − 2 teams, B − 2 teams
- U18: A − 1 team, B − 1 team
- Recommend for acceptance with following conditions:
  - O Roster size is same for all tiers in a division

## Lumsden

- U9: 2 female C teams
- U11: A 1 team, B 2 teams, C 1 team (maybe a Female team)
- U13: 1 team at A, B, C
- U15: 1 team at A, 2 teams at B
- U18:1 team at A
- Recommend for acceptance with following conditions:
  - O Roster size is same for all tiers in a division
  - O Defer decision on U9 female teams

## Moose Jaw

- U11: A 1 team (this might be 2, depending on the players that left to join the non-sanctioned program)
- U13: A 2 teams
- U15: A 1 team
- U18: B 1 team
- Recommend to accept
