# Registration

### **Evaluations**

- No changes to process except for U13 Female:
  - o Process will be the same as U13AA Coed
  - o 1 skill session, 1 scrimmage, then a cut
  - o Followed by 2 more scrimmages
- Drills for skill sessions to be developed by HRI
- Drills to be more division and tier appropriate
- Goalie session to be at the beginning of each skill session

### **Evaluators**

- 6 independent evaluators for all tiers except the lowest tier. The lowest tier only 3 independent
- Coaches are part of the evaluation process
- The ratio of independent scores vs coach scores will be at a minimum 60/40, except for the lowest tier
