# Hockey Regina Inc. U7 Director Report 2022-23

The U7 division had a great season overall. There were 288 participants registered, 260 male and 28 female. In total there were 21 teams, 2 of which were designated female teams. This is a slight increase from our 2021-2022 season.

The format for practices/games was the same as last year -2 hours of practice and 1 hour of game time per week. The intent for this division is to focus on development of skills - passing, stick handling and shooting. The smaller ice surface allows for more 'touches' of the puck, supports skating skills (especially stopping and edge work) and helps all players truly be part of the game.

HRI's coach mentorship program had 4 mentors assigned to the teams, with every team seeing involvement in this capacity. The mentors provided valuable support and feedback to coaches in the development of practice plans and ways to best support various skill development.

The season concluded with the Jim Odling Timbits Jamboree and a great weekend was had by all. A huge thank-you to the Coaches, Managers, Treasurers, Parents/Guardians and others that volunteered their time all year to ensure the season was successful. It is so greatly appreciated!

In conclusion, this has now completed my second year on the HRI Board of Directors (both as the U7 Director) and I want to thank the HRI staff, Board and membership for supporting the sport of hockey in our community and ensuring that we continue to provide positive experiences for all the youth that lace up their skates and step on to the ice.

# Hockey Regina Inc. U9 Director Report 2022-23

In 2022-23 again there were three U9 Divisions. The number of teams remained like previous years with Regina fielding thirty-six U9 teams.

U9 serves as the foundation upon which the entire hockey experience is built; focusing on player development is a key priority. For this reason, teams were small on purpose to allow coaches more time to spend with each player.

The half-ice game is to be played five on 5 (skaters) and one goalie from each team. Alternatively, the teams may alter the format, 4 on 4 or 3 on 3, if the number of players on one or both teams is less than 10 skaters.

To improve experience, Half-Ice Boards were purchased and have been used in both Doug Wickenheiser and Al Ritchie rinks. We recognize there were teams that did not have the opportunity to use the boards this year, however, every team received equal ice time which is HRIs priority. For the 2023-24 season, the scheduler will consider reasonable opportunities for all teams to have access to the Boards.

Congratulations to all the players moving into U11, and welcome to all the new U9 players.

# Hockey Regina Inc. Player Development Director Report 2022-23

Player Development begins with choosing the right coaching staff, and we had another year of excellent coaches. We again tried to focus on Goalie Development this year, however, due to ice time and scheduling constraints we were unable to offer all the Goalie Development sessions we had planned. Goalie Development Sessions were offered to U9 and U11 goalies and we were very excited to see over 40 players interested in U9 and 30 in U11. We were also able to act on a few of the Lessons Learned from last AGM (noted below).

### Lessons Learned from last AGM:

- 1. Issue: 7AM Saturday Morning Ice times Parents and kids were not fans of the 7AM ice times we had booked for the sessions last year. This year we did not have one 7AM ice time.
- 2. Issue: Parents did not receive the recruitment survey from HRI to sign-up for the sessions This year the Director of Player Development reached out to each coach individually to generate a list of players that were interested in the position.
- 3. Success: Rob Muntain as the instructor Everyone enjoyed having Rob and his helpers run the sessions. We were able to hire Rob again for the 2022-23 season.

With a new Director of Player Development in place there will be opportunities for new ideas and to expand Goalie Development in the future.

### Areas of Potential Opportunity for the future:

- 1. Book ice time with an instructor in advance of the season beginning for the Goalie Development Sessions
- 2. Expand Goalie Sessions to include U13 and U15
- 3. Create a Goaltending recruitment and retention committee to look at what other options are available.

### Officials Committee - 2023 AGM

The 2022-2023 hockey season was an extremely exciting season with our first full season for a couple of years. Although, there are challenges with retention of older officials Hockey Regina found a huge influx of new officials this season. This was the first year which we could assign seasoned officials with new officials to ensure mentoring young officials to assist with Hockey Regina's goal to provide an experienced officiating group for all divisions.

#### **New Officials**

This season there were 146 new officials registered with Hockey Regina, however, not all officials worked games after registering. This season there were 15 new female officials registering which was the largest increase in female officials to date. Hockey Regina received new officials registering consistently all year right to the start of March which unfortunately was a challenge to assign some of these officials consistently for games. However, we have found that there was a very good group of young officials with very good skating and good work ethics.

#### **Retention of Officials**

The number of officials in Hockey Regina membership was increased to approximately 380 up from 300 at the end of the year last-year. There were around 60 officials-deciding not to return for various reasons. The majority of officials were the senior officials and officials in their late teens. This is the biggest challenge to retain officials in the ages of 19-25 years of age. Hockey Regina ended with approximately 380 officials however, approximately 80% of officials are working on a consistent basis. At the end of January we found an additional 34 officials have not completed their accreditation so our numbers may be lower than expected. The challenge is definitely, to continue to support and retain our officials.

### Supervisions

The number of supervisions have increased substantially from approximately 100 supervisions in 2021-2022 to over 350 supervisions this year which is back to our target level of 400 per year. This was the result of both an increase in supervisors. It is still a challenge to complete these supervisions due to the supervisors are also officiating High Level Hockey and/or officiating numerous games and the time commitment is high.

#### Official Complaints

This year Hockey Regina Officials Committee dealt with 2 formal Official Complaints. The Hockey Regina Officials Committee found that all complaints were based on the coach determining that the official was not qualified to officiate at the particular level. Unfortunately, the validity of the complaints were not substantiated by the ability and experience of the officials. The complaints historically are submitted as the Hockey Regina Provincial Qualifiers were being completed and the intensity of the games are higher. It does appear that the majority of games both the coaching and players and officials are conducting themselves in a professional manner throughout the games.

### **Games Scheduling**

Weekend scheduling continues to provide challenges to Hockey Regina Officials where most of our games are scheduled and we have the least amount of officials available. We have learned that there may need to be a revision of how to schedule hockey games on weekends. Normally, schedules have the lower age groups in the mornings and older divisions scheduled in the evenings. With less senior officials available, it was challenging to fill games in the evenings at the U15 and U18 games and for the first time Hockey Regina scheduled U18 officials for U18 games. This does not provide for an effective utilization of resources and is contrary to our goal to provide for a quality officiating crew for a positive on ice experience for the teams. For the 2023-2024 season, it may be more efficient to review scheduling for weekends especially during tournament weekends.

#### Sask First

Hockey Regina had a strong showing in the Sask First Programs with both Female and Male. The Hockey Regina Officials Committee have identified approximately 40 additional young officials who should ensure they participate for the 2023-2024 season. The most positive aspect of this season was definitely how the majority of officials worked additional games to ensure games were covered. In addition, it was also very positive seeing the growth of the young officials who were challenged in higher divisions than they have normally officiated.

### **Positives**

Hockey Regina officials were utilized in numerous communities throughout the year assisting rural communities. In addition, Hockey Regina officials were very prominent in the Saskatchewan provincials throughout Southern Saskatchewan.

There is a promising group of young officials both male and female which should continue to provide Hockey Regina with a base of talent for numerous years.

Overall, a very challenging year however, a very positive experience for everyone involved this year. I would like to thank the Hockey Regina Officials Committee for all of the work they have done this year to ensure that Officials, Coaches, Players and Fans had a positive experience.

Discussion has also started in opening this up as a mentorship from older age group goalies (U13/U15/U18) to younger goalies (U9/U11) which we will look to see if there is interest to get this off the ground.

#### INDEPENDENT AUDITORS' REPORT

To the Members, Hockey Regina Inc.

#### Opinion

We have audited the financial statements of Hockey Regina Inc., which comprise the statement of financial position as at April 30, 2022, and the statements of operations, changes in net assets and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Organization as at April 30, 2022, and its financial performance and cash flows for the year then ended in accordance with.

#### Basis for Opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information identified above when it becomes available and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit, or otherwise appears to be materially misstated.

When we read the annual report, if we conclude that there is a material misstatement therein, we are required to communicate the matter to those charged with governance.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED APRIL 30, 2022

### 1. Purpose of the organization

Hockey Regina Inc. (the "Organization") promotes and organizes the sport of hockey in the City of Regina. The Organization is incorporated under *The Non-Profit Corporations Act, 1995* of Saskatchewan without share capital and as such, it is not subject to income taxes.

### 2. Summary of significant accounting policies

The financial statements have been prepared in accordance with Canadian accounting standards for not-for-profit organizations which required management to make estimates and assumptions that affect the reported amount of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of revenues and expenses during the period. These estimates are reviewed periodically, and, as adjustments become necessary, they are reported in earnings in the period in which they become known. The financial statements reflect the following policies:

#### Financial instruments - recognition and measurement

Financial assets and financial liabilities are recorded on the statement of financial position when the Organization becomes party to the contractual provisions of the financial instrument. All financial instruments are required to be recognized at fair value upon initial recognition, except for certain related party transactions. Measurement in subsequent periods of equity instruments is at fair value. All other financial assets and financial liabilities are subsequently measured at amortized cost adjusted by transaction costs, which are amortized over the expected life of the instrument.

Fair value is the amount at which a financial instrument could be exchanged at arm's length between willing, unrelated parties in an open market. Changes in fair values of financial assets and financial liabilities measured at fair value are recognized in excess of revenues over expenses.

When there is an indication of impairment and such impairment is determined to have occurred, the carrying amount of financial assets measured at amortized cost is reduced to the greater of the discounted cash flows expected or the proceeds that could be realized from sale of the financial asset. Such impairments can be subsequently reversed if the value improves.

#### Inventory - hockey equipment and sweaters

All inventory purchases of equipment and sweaters are expensed as incurred.

#### Tangible capital assets

Tangible capital assets are recorded on the statement of financial position at cost less accumulated amortization. Amortization for computer equipment is provided on the straight line basis over three years and equipment on a straight line basis over five years. Leasehold improvements are amortized on a straight line basis over the term of the lease.

### Revenue recognition

Registration fees and sponsorships are recognized over the hockey season, which begins and ends within the Organization's fiscal year. Try-out revenues are recognized when the activities occur. Interest is recognized as it is earned. Contributions for tangible capital assets are deferred and recognized into revenue on the same basis as the asset is amortized. Fundraising revenues are recognized as the activities occur and collection is reasonably assured. Other revenues are recorded in the period the amounts are earned.

### 8. Financial risk management

The Organization has a risk management framework to monitor, evaluate and manage the principal risks assumed with financial instruments. The significant financial risks to which the Organization is exposed are:

#### Credit risk

Credit risk is the risk that one party to a financial instrument will cause a financial loss for the other party by failing to discharge an obligation. The Organization is exposed to credit risk on accounts receivable. The Organization incurred insignificant bad debt expense during the past three years.

### Liquidity risk

Liquidity risk is the risk that an entity will encounter difficulty in meeting obligations associated with financial liabilities. The Organization's exposure to liquidity risk is dependent on the receipt of funds from its operations and other related sources. Funds from these sources are primarily used to finance working capital and capital expenditure requirements, and are considered adequate to meet the Organization's financial obligations.
