3.1 Midget Hockey Review

The Committee discussed the following with the Sask Female Development announcement.

- Good start with what has been completed with 11 Midget AA and 7 Bantam AA to start.
- Timing of announcement
 - : Provide a little more time.
 - : More communication prior to the announcement to let teams know when the announcement will take place. Provides an opportunity to get team together.

Midget Male Review

- ➤ Any Changes would be for the 2020/21 season
- October 1, 2019 deadline for applications

Midget AAA Male

- All teams essentially will be eliminated, and all will have to reapply.
- Similar conditions to what was expected with the Female teams in terms of local coaches, billet coordinator, etc. Must have a Midget AA Team in the community as well.
- Accept up to a maximum of 12 teams.

Midget AA

- Accept up to a range of 15-20 teams.
- Dependant upon membership feedback on the creation of a Provincial 15-year-old league.
- Similar conditions to what was expected with the Female AA teams.

Midget 15-Year-Old League

- Provincial League to fall under the Sask AA Hockey League.
- Accept up to a range of 6-8 teams in a Provincial League.
- Similar conditions to Midget AAA with a billet coordinator, educational coordinator, etc.

The concept will be presented at March Zone Meetings for feedback, reviewed by the Committee again and then a recommendation made to the SHA Board of Directors for their meeting at the end of April. Following that MHA's will be advised of the application process and the October 1, 2019 application deadline.

3.2 Atom & Below Hockey (Tiering/Carding)

The Committee had a lengthy discussion on many different concepts of Tiering/Carding Players/Teams in Atom and below. Some of the basic items agreed to where;

- Geographic subdivisions closed at Atom & below to MHA's from outside participating within their leagues.
- The four geographic subdivisions can tier to a maximum of three tiers.
- All other MHA's could tier to a maximum of two tiers.
- If teams outside the four geographic subdivision tier, the players on the highest tier cannot be registered on a "carded" team.
- "Carded" teams can be registered by December 1 annually to compete on four "Carded" weekends (Friday-Sunday) annually; 2nd weekend in December; 3rd weekend in January; 3rd weekend in February; 1st weekend in April.

Kelly and Derek will come up with other options to circulate to the Committee.
