Suggested changes to improve goaltender recruitment and training

- 1) Policy change
  - Summer hockey schools must have identified goaltending coaches and specific instruction or we do not allow them to advertise or provide links on HRI site
- 2) Suggest 6 full ice goalie sessions per year (1/mo) per division or 2 divisions as part of program
  - Scheduled at start of season throughout season
  - May change number depending on tier
  - Must attend part of same as normal team practices, unless game that day
  - Teams must send 1-2 shooters per goalie session
  - Must be coordinated with division schedules
  - Depending on tier? (House/C, don't want to overkill with coaching/training requirements for someone who just puts up their hand to help out)
  - Run by off-site organizations listed below or top level HRI coaches
- 3) HRI pays ½ of cost for 1 session for every goalie each year in off-site of choice.
  - Offsite schools need to participate/run 6 yearly full ice session in trade for more business they receive. Believe they should be paid.
  - They gain benefit of PR for their offsite or summer goalie school
- 4) Other financial incentives
  - Many methods to reduce costs
  - Would prefer to look at other positive options before "bribery"
- 5) Some incentive for struggling teams and divisions to introduce not ongoing
  - Do we pay other mentors now?
- 6) Goalie coach mentors need to be appointed/hired
  - Do we pay other mentors now?
  - Ensure coaches provide
    - Skating drills for goalies
    - Opportunity for standard goalie only drills by themselves
    - 1 flow drill per practice to specifically benefit goalie

- 7) Goaltending coaches
  - Head coach must have goaltending clinic depending on tier? (House/C, don't want to overkill with coaching/training requirements for someone who just puts up their hand to help out)
  - Higher tier teams must name who their goalie coach is, not just head coach as they usually cannot dedicate time to goaltending. This person must get their goaltending clinic as well depending on tier? (House/C, don't want to overkill with coaching/training requirements for someone who just puts up their hand to help out)
- 8) Encouraging goalie recruitment at Initiation/Novice
  - Initiation jamboree should have a goaltending overview temperament/implications/costs/HRI equipment availability/encouragement
  - Possibly again at end of Novice
- 9) Try goaltending day
  - Initiation/Novice
    - Perhaps Atom a bit before tryouts
  - Players get expert instruction in proper technique on full ice surface
  - A chance to encourage players/parents waffling on playing goal to really take up the position
- 10) Review goaltending equipment inventory
  - Would like summary of
    - Number of each
    - Size
    - Models
    - Condition,
  - Need to ensure no misconception on HRI equipment
    - That it is quality
    - Is desirable (better face facts, appearance counts)
    - Can be used to reduce costs for players
  - Invest in new equipment if required
