



## Huntsville Girls Hockey Association 50/50 Raffle Official Rules

### 1. General

The Huntsville Girls Hockey Association (HGHA) conducts 50/50 raffles as a fundraising initiative in accordance with municipal lottery licensing requirements.

- Lottery Licence Number: M850761
- Licence Period: January 2026
- All raffles are subject to the Alcohol and Gaming Commission of Ontario (AGCO) regulations and municipal licensing conditions.

### 2. Eligibility

- Ticket purchasers must be 18 years of age or older.
- HGHA executive members directly involved in the administration of the raffle may purchase tickets but may not participate in the draw process.
- HGHA volunteers assisting with ticket sales are permitted to purchase tickets.

### 3. Ticket Pricing

- Tickets are priced at \$5 per ticket or 5 tickets for \$20.
- Ticket prices are fixed and non-negotiable.
- All ticket sales are final. No refunds will be issued.

### 4. Ticket Sales Locations

- Tickets may be sold by HGHA teams and approved volunteers.
- Players may sell tickets independently throughout the Town of Huntsville, including, but not limited to the Huntsville Summit Centre, to family, friends, and community members (e.g., door-to-door or private sales).
- Association-run, in-person ticket sales will be conducted at an HGHA-operated table at the Huntsville Summit Centre during the HGHA Home Tournament.
  - Ticket sales are not permitted at Baysville Arena or Burk's Falls Arena through the association.

### 5. Payment Methods

- Accepted payment methods include cash, debit/credit (subject to availability), and e-transfer (subject to availability).

- HGHA is not responsible for technical issues related to electronic payment systems.

- HGHA may establish a cash float to facilitate cash transactions.

## **6. Prize Structure**

- The winning ticket holder will receive 50% of the total gross ticket sales.
- The remaining 50% will be retained by HGHA to support association programs and operations.
- No minimum or maximum prize amount is guaranteed.

## **7. Draw Details**

- The draw will take place on February 4, 2026, at 7:00 PM.
- Location: Canada Summit Centre, during the monthly HGHA Board Meeting.
- The winning ticket number will be drawn at random.
- The ticket holder does not need to be present to win.

## **8. Winner Notification & Prize Claim**

- The winning ticket number will be announced at the draw and posted on the HGHA website and/or social media platforms.
- The winner must present the original winning ticket to claim the prize.
- The prize will be paid by cheque, issued after ticket verification.
- Prizes must be claimed within 90 days of the draw date.
- Unclaimed prizes will be handled in accordance with municipal licensing requirements.

## **9. Record Keeping and Compliance**

- HGHA will maintain accurate records of ticket printing, distribution, sales, and prize payouts.
- All proceeds and expenses will be reported as required by the licensing authority.

## **10. Liability**

- HGHA is not responsible for lost, stolen, or damaged tickets.
- By purchasing a ticket, participants agree to be bound by these rules and all applicable laws and regulations.

## **11. Amendments**

- HGHA reserves the right to amend these rules if required to remain compliant with licensing or regulatory requirements.
- Any changes will be posted on the HGHA website.
