1.	Stephen Bates called meeting to order at 7:31 pm			
2.	Additions and approval of agenda  Teresa Dodd made motion to accept the agenda as presented. Candace Schmidt seconded. Motion  Carried			
3.	Reading and adoptions of minutes: July 21st, 2020 Candace Schmidt made motion to accept minutes as presented. Bruce Rafuse seconded. Motion Carried			
4.	Old Business  a) Town Bill/Finances  • Putting outstanding incoming payments from last season towards balance  • Can the town waive interest payments? Quite large for a non-profit community group			

### New Business

- a) Registration Numbers
  - Age directors received lists & numbers
  - 200 total registrations with 7 in progress on registration app
  - Expecting to have 9 from Bowden & Delburne
  - Approximate Numbers:
    - Eaglets & U5 7
    - U7 18
    - U9 20
    - U11 36
    - U13 48
    - U15 42
    - U18 31
  - Sock supply may be issue especially for larger sizes
  - Try and get registration night done with Town. Town initially indicated no registration night & then later sent out request to pick a night for registration
  - Positive numbers given environment and town's approach
- b) Female Registration Numbers
  - Female Director not here
  - Only 1 female indicates only to play female hockey
  - Recommend that we have NO Female teams declared again this season
  - Will help find homes for the female players that do not want to play mixed hockey
  - Teresa Dodd made motion to declare no Female teams for the 2020/21 season. Bruce Rafuse seconded. Motion Carried
- c) Town/IMHA Return to Play Plan
  - One major change from original plan instead of 15 participants in lobby it is 25 participants
  - One online meeting was only 30 minutes and was not sufficient for this type of plan/response so was lacking and we were unable to ask questions
  - Ice supposed to go in on the September 14<sup>th</sup> on the blue side. Ice times will remain normal
  - No red side date announced & no anticipated date for this surface to open
  - Players will have to be dressed and then put on skates in lobby (can have small bag which has to go to player's bench)
  - 1 parent per kid can go in to tie skates and then have to leave rink
  - Question about how to handle younger participants who often are upset or have to use the washroom multiple times. Will town have resources to handle this?
  - Evaluations will go ahead for team selection
  - Hockey Alberta & Hockey Canada not allowing travel currently
  - Discussion on whether season should be equal teams split for games or be a development season. Thoughts are a development season with in-team scrimmage
  - Goalie training & Power skating may be impacted as coach may not be able to cohort to many teams unless done via social distancing as camps/clinics are (even Hockey Alberta are hosting these currently)
  - Discussion on screening protocols for rink
  - Hockey Alberta deadlines/requirements remain same for Coaches (Nov. 15). Coaches can do online 'Return to Hockey Safety Guidelines'
  - Coach can only be on bench for one team only this season
  - Siblings must be on same team if at same level
  - Continue to be much gray & unknown. Hockey Alberta is having another conference call tomorrow on this
  - Committee for our IMHA return to hockey plan: Megan McDonald, Lorne Harrison, Stephen Bates, Teresa Dodd & Bruce Rafuse

### d) Coach Selection/Approval

- Reviewed current Coach applications:
  - Many positions had no applicants, particularly U15. We need to encourage any potential Coaches to get apps in
  - Coaches were approved or removed as potential coaches for up-coming season.
     NOTE: They are not named to a team, only pre-approved & will need to be ratified and named to a team later
  - Applications still open for 'A' Coaches until August 31st, 2020
- e) Edge Boss Update
  - Pat Seely (distributor) needs to know when we would like Edge Boss equipment delivered.
     Ideally, we will look at end of October/start of November
  - Find costs on putting name/logo on (theft deterrent) & cost of storage/transport cart
  - Storage & access plan
  - Larry Reid fund will assist
- f) Golf Tournament
  - September 13<sup>th</sup>, 2020 Noon start
  - Our cost is \$40 per golfer for 9 and a cart & \$15 for dinner. Suggest charging \$80-\$100.
