4. Old Business

- a) Fundraiser Update and Plan Draw
 - Collected tickets & money last week (Tuesday/Wednesday). At that time less than 80 unsold tickets & IMHA Directors took those to sell
 - 16 unsold as of tonight, IMHA Directors will sell those
 - Close to \$20K in raffle account
 - Will post something on Social feed when all tickets are sold
 - Draw will be March 31st, 2020 @ 6:30PM at arena (Will broadcast via Facebook live)
- b) Last Year's Awards (2019/20)
 - Will do it in conjunction with draw night at arena (now that we have nicer weather & longer daylight) on March 31st, 2021
 - Unfortunately, IMHA will not do Awards for 2020/21 season due to Covid
- c) ED Job Review
 - Brett Kelly, Teresa Dodd, Candace Schmidt & Bruce Rafuse will form committee to review Executive Director job

5. New Business

- a) Team Photos for Sponsors
 - Framed team picture available for each sponsor
 - Ideally team staff will deliver to sponsor & take photo; sooner than later
- b) Budget Finance
 - Reviewed documents shared via email
 - 2018, 2019 & 2020 Financials completed now by Perry Cruickshank
 - Applied for loan/grant program from government
- c) Registration Fees and COVID Updates for Approval
 - Majority picked 60% rebate for next season
 - 10 locals requested full 60% rebate (moving, leaving for girl's hockey, etc.). Teresa Dodd makes motion to grant the full 60% of rebate on these 10 requests. Brett Kelly seconded.

Motion Carried

- Over \$40K to be refunded
- Refund Process; Pilot request on 10th & was returned on the 11th to our trial subject. Need to see if we will have refund fees; do not believe so. Rebate amounts will show in TeamSnap if we refund that way.
- Target cash refunds by April 30th, 2021
- d) Board Recruitment
 - Email went out yesterday from Recruitment Committee asking current IMHA board members about intentions for next season. (Send in if undecided as well)
 - Have intentions in by end of week
 - There will be some vacancies
- e) AGM
 - Need to advertise at least 30 days prior
 - Select April 26th, 2021 LOCATION TBD (Could be outdoors)
 - Vacant positions will be advertised
 - All positions open must be applied for ahead of time, no on the floor names can stand; nominations must be in writing 1 week prior (April 19th)
 - If meeting will be via Zoon, Brett Kelly will register & set-up voting methodology

 - CAHL is moving to RAMP (Hockey Alberta is likely too)
 - TeamSnap invoices is \$1200
 - Will remain TeamSnap for payment and RAMP for web-hosting for upcoming season
