As a parent/guardian of a player, I promise to:

1. Place the wellbeing of my child before a personal desire to win.

3. Encourage my child to play by the rules and respect the rights of other players, coaches, officials and fans.
4. Advocate a sports environment for my child that is free of drugs, tobacco, alcohol and abusive language and refrain from their use during youth sporting events.
5. Help my child show up to practice and games on time, with proper equipment and ready to play.
6. Assist the volunteer coaching staff by supporting the decisions they make on behalf of the team.
7. Wait 24 hours before bringing issues to the coach/manager.
8. Present all grievances in writing after the 24 hour cool off period has lapsed.
9. Be present or have another designated adult present at all games and practices
10. I acknowledge that I will be seen as an ambassador of our team, our association, our town as well as the sport itself and will carry myself accordingly.
11. I will not participate in any kind of bullying, harassment or discrimination in the dressing room, on the floor, or on social media (Facebook, Twitter, Tiktok, Instagram, etc.). Violation of this rule will result in immediate disciplinary review.
