Reports of Committee Members:

Vice-President Field 1 - Matt Towle

In December, we faced a complex situation concerning the suspension of U11 Coach Jamie Boyd for 2 games. The core issue revolved around an exhibition game that ensued after the scheduled game was forfeited due to a shortfall of players. Initially, the U11 team had only seven confirmed players, prompting the coach to decide on a forfeiture. Subsequently, an exhibition game was orchestrated with the collective agreement of coaches, managers, and referees. However, confusion arose from an incorrectly submitted game sheet for this exhibition match. This mishap led to Coach Boyd's suspension, rooted in a misinterpretation of policies regarding cross-over players post-October 31. Notably, the existing policy primarily addressed forfeited regularly scheduled games, leaving a gap concerning exhibition games. Upon review, it became evident that the submitted game sheet pertained to the exhibition, not the forfeit, leading to arguments against the legitimacy of Boyd's suspension. This incident underscores the imperative for clearer guidelines on exhibition games post-forfeit and emphasizes the need to educate team managers on the correct protocols for game sheet submissions. Looking ahead, there's a recognized need for enhanced management practices, especially concerning player commitment in the U11 category. Moreover, there's a pressing demand for a revised policy to comprehensively address the intricacies of exhibition games and forfeits, aiming to refine and fortify the operational integrity within the VIFLL. At this time, we are still working to get this unwarranted suspension lifted.

Vice President Field 2- Devin Johns

Matt has done a great job explaining the largest issue that has come up since the last meeting.

It is going to take some time to figure out how to best move forward in the future to work with VIFLL and ensure these issues no longer impact our volunteers (coaches and managers) and allow games to be played whether that is an exhibition or a league game.

Kids want to play games and I am not sure that the system as a whole for the island has found a way to make that happen this season from u17 all the way down to our youngest ages from coed to female for many reasons not within our associations control.

I can see we have a great group here and I look forward to helping moving forward!
