**Reports of Committee Members:** 

#### **President** – Adam Ranns

There are a lot of lacrosse events going on and I will let everyone else update how they are going when they do their position specific updates.

I have a meeting scheduled with MLA Ravi Parmar this Tuesday to see how Langford can help with JDF lacrosse. Please let me know any thoughts or ideas you have that I can bring to this meeting. I will let everyone know how that meeting goes February 1 when we meet.

I met With Lucas McNeil to discuss some issues with parents, players, and other topics and how JDF and Royal Bay can help in these areas. Below are some ideas that we discussed and I want to see what everyone thinks about them. I have another meeting TBD with Wayne Kelly and Lucas to discuss this further.

- A class room session for coaches not just to learn the game but how to handle different
  difficult situations with parents. We have a lot of new coaches and between the
  executive at JDF and the coaches at Royal Bay there is a lot of lacrosse experience and
  we can help coaches new to the game come up with practice plans, game plans and
  learn the game.
- A class room session for parents. This could include learning the game (more field lacrosse than box). How we are looking to develop kids and not hurt them by putting

them on B teams and the process that we go through looking at that. Also the behind the scenes on how NCAA institutions hand out scholarships, the dollars involved and how each NCAA division manages team size with scholarships. There are lot of parents that do not understand the process and think their kid needs every top opportunity they can get and this causes a ton of issues. In my discussion with Lucas, he was unaware that a lot of division 2 coaches have a roster minimum in their contract and that number is quite high. If a player has good grades, good work ethic, and mediocre skills they will take them in a second to meet that roster minimum without using capped athletic scholarship to get them there. Dawn and I have a ton of experience in the NCAA setting and we can help with that area and hopefully be able to help not only parents but possibly Royal Bay as well. Curt and Nic have a ton of experience in Senior and Junior lacrosse and hearing information on how to get to those levels in box lacrosse would be great also.

- We are going to look at the JDF parent contract and the one at Royal Bay and see where we can strengthen both of ours together
- I would like to discuss with everyone the idea of having a set "motivational" work out in place when players are goofing off, hurting each other and not listening. Royal Bay and JDF have both received complaints from parents saying we are being too harsh in conditioning or disciplinary work outs. For this reason, if the executive agrees this is a good idea I would like to reach out to a friend of mine who is a college strength and conditioning coach to get some set work outs in place from a professional certified coach. He has worked with multiple NCAA lacrosse championship teams, the New Zealand national team, and The Charlotte hounds professional lacrosse team. This is now mandatory in NCAA institutions and could be something good to hand to the coaches.
- Have each coach send an expectations email out to the parents outlining their expectations for the season as well as have a parent meeting outlining these expectations.

I met with the lower island presidents to discuss teams as well as if there was a possibility of readding an intermediate level lacrosse for those that don't make any of the junior teams. I agreed that there are a lot of kids who don't make those teams and then have nowhere to play but being newer I have no idea how or if this can be done. The Peninsula President is going to explore this further.

#### Vice- President Box 1- Niki Williams

A good start to the season so far. Good turn out at our Eagle Ridge sessions. Try lacrosse and bring a buddy sessions are complete.

Healthy numbers at U11 and U13. I'm confident we will have four, maybe five balanced U11 teams and four tiered U13 teams...

A1, A2, B & B. Right now our numbers are tight for 4 teams, but its still early and I'm confident we will get there.

I'm meeting Gina and Jill at the locker tomorrow to do a full inventory of our jersey stock and to load it into a digital database that Jill created. This will streamline the process and set up our jersey coordinators for success moving forward.

I will be attending the VIMLC planning meeting Feb 5th.

#### Vice-President Box 2 - Nic Collison

Keeping an eye on U15 numbers and will wait lost shortly. If a couple more come in. Will advise. U17- 2 teams and only 1 registered goalie. So a little work around with that. Off to a great start.

## Vice-President Female - Dawn Ranns

The U11, U13, U15, and U17 female season finished up this week with a final practice and a double header scrimmage against Nanaimo for the U11/13 team. Overall it was a successful year and we are looking forward to growing the rosters on all age groups for the coming season.

Female Box registration is under way and slowly increasing in number. To date we have 6 U13, 4 U15, 3 U17, and 1 U22 registered. We will continue to work with VELA to promote the season and grow the numbers. We have a Female Box session setup for February 8 from 5-6 PM at Eagle Ridge. We will continue to promote the session and work on increasing the number of registered players.

The U11, U13, U15, and U17 female season finished up this week with a final practice and a double header scrimmage against Nanaimo for the U11/13 team. Overall it was a successful year and we are looking forward to growing the rosters on all age groups for the coming season.

Female Box registration is under way and slowly increasing in number. To date we have 6 U13, 4 U15, 3 U17, and 1 U22 registered. With VELA and JDF registration so far we have one team at U13F, U15F, U17F, and U22F. We have half a U11F team so far, but we need more if we are going to declare a team. The season will run April to June. Practices at Bullen and Topaz with occasional practices at JDF boxes. We schedule the female practices a bit later for travel time and rotate indoor practices for U17 and younger. U22 has one standing indoor practice at Archie Browning on Wednesdays. The game schedule is still being sorted by the island commission and Lower mainland commission. We will play Nanaimo and likely have 2 lower mainland home games and

2 lower mainland away games (played on the same day). Should be 12-14 games total. U11F would not play mainland teams. We won't get those details until closer to March.

We have a Female Box session setup for February 8 from 5-6 PM at Eagle Ridge. Blake Moyen (U13F coach) and Dawn Ranns will run the drop in session. We will continue to promote the session and work on increasing the number of registered players.

#### Treasurer - Jesse Lawson

Despite some process and administrative delays, we were finally able to transition the banking authorities over. I have been playing some catch up with paying bills and addressing refunds but I am working through it. There is a large volume of movement through our accounts due to registrations coming in and Field teams wrapping up.

I have met with the Administration at Westshore Parks and Recreation and we have started our payment plan to cover the outstanding debt. This will be a monthly expense for the calendar year.

I will be looking to review (and possibly propose a new) process for suppliers such as Kirby's Source for Sports.

Registration is going well, we have about 285 registrations so far total, which is about 80% of registrations based on last year's numbers.

#### **Head Coach** Box - Curt Morwick

Coaching are in place for the upper divisions. The assessments have been running well and we've been getting positive feedback. All in all things are good. I'm working on putting together some practice plans for coaches in if they would like. A few drills and different focuses in case they want some fresh drills or ideas. There was talk about a parent contract for the upcoming season. Following up on our conversations from our previous meetings, I'll reach out to the coaches to recommend they have their own letter as well as our JDF letter for parents to sign. Their letter will state what the coach's progression plans look like, how they will run the team, what to expect to see in certain situations etc etc. more of a personal letter that they can draft up the letter themselves. I don't want to tell them how to run their teams, but I'll provide some key topics we think are necessary to discuss with parents. The aim is to have the parents read it and sign it to keep possible disgruntled behaviour at bay. Some teams are wrapping up their season now. I will be sending managers an email asking for their end of season package and coaches will be asked for their player nominations for the next awards ceremony. Nothing more to report for Field at this time.

# Floor Allocator - Kyla Pedlow

WSPR is now accepting requests for Spring/Summer. Below you will find the requests that I have submitted. I have also created a draft practice schedule for the upcoming box season. I don't anticipate a lot of movement or changes to this schedule. Having it set now allows me to be able to better request floortime from WSPR, schedule game slots that will be given to the Island, and give Jean days of the week that U<sub>7</sub> and U<sub>9</sub> will be practicing so that parents can schedule other activities for their kids.

One major item to note is the amount of money we saved on field rental this season. Our original contract for use of the Velodrome for the season was \$49,513.76. The most recent update I've seen is that we were able to reduce that down to \$29,393.02. So we were able to save \$20,000 by sharing practices, and slashing the amount of weekend time booked. For Royal Bay, our original contract was \$19,203.72 for the season. With our field time there being cut in December, that contract went down to \$6,753.15, which is a difference of \$12,450.57. So, in total we saved \$32,571.31. I'm hoping this makes a massive difference to our debt with WSPR. We should also still be receiving credits for the days that the fields were closed due to snow.
