When are we opening Field Registration - there has been some discussion in the past about waiting until box is done to give families a break, but at the same time, associations like Ridge are practicing throughout the summer bc they have their teams set by July. - 4. Last year we were able to publish assessment dates when registration opened will we be able to do this again this year? Is there an assessment committee in place? TBD after VIFLL meeting

For discussion (Cass I hope you are there to speak to this) - should the association impose a transaction fee for using credit cards?

Pros - it offsets any fees we incur when we have to issue refunds

It offsets any losses we incur by paying a fee to allow families to use a credit card in the first place.

Cons - It might deter families from using their credit card which means much more administrative work for me and Cass to track payments and CONSTANTLY chase families for payments

Alternative, we increase registration fees to account for the average credit card fees we incur and do not charge an additional fee only on credit cards.

For discussion - We talked about giving goalies a discount on registration, possibly in the form of a (partial) refund at the end of the season if they play mostly as goalie — just wondering where we are at for this, and if it will apply to this current box season.
