Last weekend I attended the BCLA AGM and Minor Directorate Special Session in New Westminster. Nothing too major to report, a lot of the proposed bylaw changes were pulled from the agenda. It sounds like BCLA wanted more time to prepare them properly and avoid a bunch of arguments on the floor. Most of those changes still need to happen, they're just being pushed to a later special session.

The meeting itself ran really smoothly this year. BCLA brought in Jason Robinson from Sport Law Canada to chair it. He's a Parliamentarian and ran the meeting perfectly. It was long, but without Jason it would have been way longer. They also had Greg Gilhooly, one of their lawyers, on Zoom to handle any legal questions. A few of us spoke with Jason afterward, and Sport Law said they'd be happy to help us with our own bylaw review if we want, to make sure we're compliant with the Societies Act and everything else.

While I was there, I chatted with a few other associations that are looking at moving to a governance/operations board model like we've been working toward. Seems like a lot of groups are realizing they're not quite in line with the Societies Act either. Burnaby is doing a full restructure similar to ours, their president invited me to their Town Hall last week to see how they presented it to their members. It was really well done and gave me some good ideas for when we do ours.

Lastly, we had the VIMLC AGM last night. Tim Frost has stepped down as Chair, and Andy Stuart will be taking over. Most of us know Andy from the Coach Talk Training session he ran earlier this year. I think he'll do a great job leading the Island group.

Most teams have booked 10-12 regular season games (goal was 12), aside from U18.

There has been limited uptake from the mainland in coming over to play.

Treasurer – Cass Jutting

We received our Gaming Grant in the amount of \$66,500 which is only slightly less than we budgeted for (\$70K, which is what we received last year, and we received \$66K the year before). That said, the directors need to know that the Gaming Reports were not submitted for 2019, 2020, and 2021 (noted as pre-amalgamation) but I will be able to pull the information together based on the information I received from the Gaming Grant staff. This has put us at risk of not receiving gaming grant money in the future.

The financial statements were completed and distributed for 2024-2025. The budget will be revised based on the grant info and updated revenue for this field season by December when we startup with the new bookkeeper.

BCLA have adopted a new format for registration submission which makes things much simpler, as print outs of each team or of all registrations are no longer required to be mailed in. Ramp has simplified reporting for the BCLA so registrars only need to submit digital reports by email.

Total numbers for field season = 278 + potentially 1 more pending Island approval This includes the female players.

I also attended the BCLA AGM as a voting member for field lacrosse on Oct 25 and would only add Congratulations to Jill Denis, recipient of this year's Presidents Award for JDF.

Those that do not wish to try out will be assessed. Balanced teams where applicable. Players may be released if requested. Need to manage players withholding registration waiting to see who coaches are. Set registration date and try out payment due so we can adequately plan for try outs/assessments. Not be scrambling at the last moment if there is a large group that waited to register. Every try out, removing players that are cut, or assigned to A1 even after the first session. Possible- top 10 moved to A1 team, and bottom 10 cut to B/C team. Then 2 nd session coaches cuts to divide the remaining players. Email and social media sent out to canvas coaching applications asap. Assessment committee to work out details. Look into digital scoring for try outs. Consider C teams where applicable for player development.
