## ICE SCHEDULING UPDATE

#### Linda Fennema & Grace Summerfield – Ice Schedulers

2 Ice Schedulers

More upfront season planning.

More consistent schedule for competitive teams.

Staggered dates to allow call ups.

All ice was allocated to teams at the start of the year to give coaches and managers more to work with in their scheduling meetings.

Good planning ahead allowed for other opportunities such as development sessions.

Added additional signatures on all contracts for more transparency.

Great effort made to schedule games back to back to help referee shortage.

Unused ice review.

2021-22 – 19 teams: 1335 hours = 10.9 Hours per month per team.

2022-23 – 19 teams: 1847.25 hours = 13.2 hours per month per team.

2021-22 vs 2022-23: House League: 30 more hours, 2 less teams. DS: 33 more hours. Development

Sessions: 25.5 hours, none the year prior.

Plans for next season: Trying to increase our number of hours in Kanata Rinks, Trying to move KRC-B to the 15min vs 30min, Stop paying for DNC, Continue to improve upon the work we did last year.

## **RISK & SAFETY UPDATE**

#### Aaron Murray - Risk & Safety Coordinator

Covid-19: First full 'normal' season without any covid-19 restrictions or impacts.

VSCs and Ramp: Moved to uploading electronic copies of Vulnerable Sector Checks to Ramp registration system. Lots of updates to VSCs required by volunteers – 205 VSC Request Letters issued (about 4x as many as last season). Should, hopefully, streamline verifying volunteers in future seasons. Injuries & Suspensions: Received 25 of 41 teams EoY injury logs (slight improvement from last year), 35 teams submitted logs at least once during season. 19 reports of concussions/suspected concussions (down slightly), 6 major injuries, 46 minor injuries logged. 11 suspensions reported – unclear if all copied R&S. 10 Players, 1 Trainer – 9 OWHA suspensions for gameplay, 2 team initiated suspensions for conduct 2023/24 - Season Opportunities: Introduction of Trainer Meeting and 'Den Mom' Tracking.

# **DEVELOPMENT UPDATE**

Adam Dewan - Development Coordinator > Absent, presented by Amleto Greco

Coaches Corner added to Website for Coaches and Staff with help from Comms.

Numerous On/Off ice providers information added to site.

Special Rates were negotiated with certain providers.

Coaches were given the opportunity to use providers they felt best suited for teams' needs.

Required Team On Ice Player Development up to 6 sessions per Team.

Recommended Teams to Match \$600 for Goalie Development Sessions for \$1200 total.

Teams were required to Maximize the funds allocated in team budgets for Goalie Development Sessions.

16 hours of Hockey Canada Pathway program run by SHIFT.

\$20 Drop In sessions for Ashley Holmes 1-2 times a month starting December (Weather Permitting) for all age groups.

All Comp teams watched 2-6 times by the Comp committee.

# **TOURNAMENTS UPDATE**

Competitive tournament - held November 2022, 84 teams attended.

Lady Sens tournament - held Jan 2023, 20 U15AA teams and 16 U18AA teams.

House tournament - held Mar 2023, 102 teams attended.

Etobicoke tournament: All KGHA competitive teams will again attend the Etobicoke tournament in October 2023.

Sponsorship & Fundraising - in Memory of Julia Miller: KGHA tournament fundraising in 2022-23 season in

memory of Julia Miller benefits Roger's House and CHEO Oncology - \$5,200.

# **CONSTITUTIONAL PROPOSALS**

1) Agreement to remove all mentions of ODWHA.

2) Update to Risk and Safety role to oversee, with any executive of their choosing as long as it does not conflict with them personally, any review of discipline within a team, association, or OWHA requirements, in direct relation to the by-laws, constitution, or policies.

3) Add Equipment and Registrar to both the Competitive and House League committees. When a position is held by multiple individuals, only the individual supporting a specific league will be included in the committee.

#### √unanimously approved.

4) Add Risk and Safety Coordinator to the Competitive and House Committees. When a position is held by multiple individuals, only the individual supporting a specific league will be included in the committee.

#### ✓ unanimously approved.

5) Allow for a House and a Competitive equipment coordinator (2 people serving in the function). The role will need to be expanded to support the two leagues. With the current growth of the league, it is becoming increasingly difficult for one individual to support both leagues. The expectation is that the two positions will have one vote between the two leagues, if a vote is required, and that they will assist each other in each other's leagues.
