## **Kelowna Ringette Association 2024-2025 Budget Notes** Conservative Budget – closely tied to 2024 results. Currently, showing an approx. \$18K loss. Sweetheart and registration are the big drivers. Income • Grant Income – Grant application requested \$40K – not guaranteed. The last 2 years we have received \$38K. With the cash on hand at the end of the season, it could reduce the funding we receive this year. Player Registration – Increase by \$25/player – offset increases coming from Ringette BC Team Sponsorship – team money that flows back to the teams Scholarship Funds – Receive annual amount of \$250 from TORL – 2 years-Licensed Gaming (Sweetheart) - \$6K (50/50) Development Programs – Fees charged for additional ice/development Ice Sales – With ice costs increasing, increase in income expected SH Tournament – This is difficult to estimate. Kept it conservative as it's hard to know how many teams will participate. **Expenses** Advertising & Promo – Focus on brand recognition to drive registration numbers. Ice Costs – Expected increases in ice costs Bench Staff – Recognition (Coach Week in September) Scholarships – For KRA players attending post secondary education programs (application process) Development Programs – includes costs for Provincial Reg Fees, Coach development (18+ player/volunteer), team/player support to attend large comps (Westerns, Nationals), team development/bonding, coach development and other new programs. This will be dependent on gaming grant income funding and SH net income. Now tied to volunteer hours.
