- After a good start to the season, penalty minutes have been on a steady increase, with a number of KPMHA teams leading or near the lead in pims for league play. More work needed on this yearly issue.
- Attended Budget Committee meetings, will discuss proposal on Monday.

Ice Scheduler – Michele Taron

- Ice schedules are up on the website till March 1st. There are still some weekend ice slots being held for possible future Rep games.
- Worked within the budget committee and was unable to all agree on 1 proposal to be presented to the Exec group so two separate budget proposals will be presented.
 - I have concerns over ice. I was able to obtain more ice this year than I will be able to in the future. Many factors came into play in regards to our average ice costs/times.
 - I was asked to give more ice to Atom Dev and some of the younger divisions.
 I wish it was possible to give everyone more ice.

In Budget #2 proposal you will see a min of extra ice squeezed in;

- 5 extras hours so the Initiations can have some game time after x-mas.
- 6 extra hours after x-mas so the Novice Major team can complete Atom transition.
- Novice Minor and Atom C also has 6 extra hours spread out over the season when availability allows it.
- Last year's budget had a large expense line for jersey purchases and a substantial contingency fund, which has changed for next year.

Due to this, Budget #2 lowers the registration fees for Rep teams.

The official's costs have gone up so therefore fees for recreation teams cannot be lowered, while continuing to provide them up to 14 games. The adjusted official's charges for Novice is 10 games since they cannot start playing games until December 1st.

- I have worked on 5 separate budget committees during my time at KPMHA, & having a budget that covers the baseline cost of our program without having members pay for unnecessary items has always been important to me.
- I have asked all managers to carefully look over the posted ice schedules and report any conflicts to me.
- There have been a lot of game/time changes at the recreation league level.
- Once recreation league play is complete then the plan will happen for play offs.
- KPMHA will be the host to the Bantam Rec Semi Finals and Finals on the weekend of March 9th/10th.
- If any teams want to purchase ice after the weekend of March 9th, they will need to let me know ASAP what they are looking for.

Treasurer – Julie Charbonneau

- The budget committee has not been successful in producing an agreed upon budget to present to the board.
- I have attached the budget I have been working on. There are a few tabs for your review:
 - Budget
 - Budget Revised Ref Policy
 - o Notes
 - Procedures and Policies Changes
- In both these versions, you will find highlighted in orange the categories that are new and require a discussion amongst the Board.
- Under the Budget tab, you will clearly see the breakdown in registration fees for recreational and rep players with the existing policy around officials. There is a clear disparity in value received by rec and rep parents.
- The Budget-Revised Ref Policy tab is what I would feel more comfortable presenting to the membership at the AGM. I propose to transfer \$30/Novice player and \$50/Atom-Midget player to their respective teams once the teams have been established (approx. \$900/team) to help cover some of the ref fees. This would allow the teams that want to fundraise and/or obtain sponsorships some time to do so and in turn creating the possibility to eliminate the need for Seed Money.
- I strongly recommend that we open 3 additional bank accounts to help us plan for the foreseeable expenses, such as future jersey replacements and unforeseeable expenses. The third is related to the Financial Aid that is already established in our bylaws. I will be bringing the references that clearly state our ability to have funds in savings/investments. The policies for the gaming grant stipulate that we can only have up to 50% of our operating costs in savings to be eligible for a grant.

Changes to Fees:

- Tryout fees should be going from \$50 to \$75
- Registration fees should go up by \$50 for Initiation and Atom
- Rep fees for Atom Development and Midget A should be brought down (Midget has less ice)
- As mentioned, the Budget with the revised policy is a product that I can easily explain to all members. As someone who works in finances, it is important that I present a product that is fair, transparent and that offers fiscal responsibility by planning for the future.

- Unfortunately due to weather conditions the Midget A playoff game on Friday got cancelled. Waiting for news on what happens next.

Equipment/Risk Manager – Kevin Kostin

<u>Equipment</u>

- I would like to discuss the replacement and purchase of jerseys for Atom division. Our current position and budget for this year has the funds set aside for the Atom Development team and both PeeWee house teams. There will be a remaining balance of \$1700.00 (\$11k minus \$9300) which I'd like to use to fill in supply gaps in sizing.
- We need jerseys for Atom house. This year we used all the remaining McAtom jerseys and do not have supply for next season. It is my intent to have all teams from Novice to Midget taking to the ice wearing proper KP uniforms. For that I need to purchase 3 sets of home and away jerseys. Approximate cost as per quotation from Hometown would be \$9300.00.
- In addition we need jersey garment bags to properly store and issue team sets. The cost for these is quoted at \$275.00.
- Goalie equipment purchase will be dependent on our decision with goalie training and the "way ahead" for our goalies. I've purchased only two additional sticks at this point as they were 60% off at Kirby's.
- I'm getting the cross ice divider boards cart repaired. Token welds and needs attention. Nathan Eror has agreed to take on the job and it should keep our costs reasonable.

Risk Management/Safety

- Nothing significant to report at the moment for current situation.
- As I mentioned previously at our meetings ... I am having dialogue with a volunteer who is willing to add

expertise to our Association in this area. Working out some details still but if successful, James McDonald will work with me overseeing CATT training, Baseline testing, incident reports and general awareness seminars for families and coaches. Basically our own "in house" sports physiotherapist and safety consult. More to follow.
