# 2021 Season Expectations:

- Provincial Government and Baseball Alberta (currently in Step 1 Phase) February 8<sup>th</sup>,2021
  - No Group or Team sports permitted
  - One-on-One training permitted
  - Trainers masked at all times and maintain 3-meter distance, unless all from the same household
- Step 2 Baseball can resume No further info yet
- Return-to-Baseball requirements and season options:
  - Requirements:
    - o Informed Consent and Assumption of Risk Agreement i.e. injury and COVID risk
    - o COVID screening and tracking log
    - Team and Equipment disinfection protocols
  - Season Options (possible start date of May 8<sup>th</sup> TBD):
    - 1. Cohort of 50, does not include coaches / umpires / staff
    - 2. Cohort of 50, Teams will be placed in Cohorts and play 2-3 weekends, 2-week break, then new Cohort team (2-3 weekends), Break and so on. Dependent on 2 or 3-week play schedule
    - 3. Normal Season no restrictions
- Baseball Alberta Zone 4 Director is Ryan Lucas
- Batting Cage no financial assistance from Baseball Alberta for 2021, hope to provide grant in 2022
- Apparel Date TBD Reds Source for Sports will again be our one stop shop to host an apparel day with discount offered on this day for baseball equipment.

# 2021 Registration Change:

- Please register by **February 19**<sup>th</sup>, **2021** 
  - Initial registration will not have the option to pay by Credit Card, only a cash option (No actual cash transfers will happen). CASH or CHEQUE will not be an option or accepted when payment is requested.
  - No payment will be required at this time. Registering provides an easy way to send email to all interested players and not spamming families that were registered in 2020.

- Once the season is a go all registered players will be required to pay by credit card with a deadline to do so.
- Registration process includes a section to indicate if interested in volunteering to coach.

#### 2021 Financial Report:

2021 budget is a roll over/copy of the 2020 budget. Registration numbers for 2020 were estimated before COVID pandemic. It is difficult to estimate registration numbers for 2021. This value may be inaccurate.

Tania tried to get reduction of insurance costs for 2020 but was unsuccessful.
