SPECIAL BUSINESS

Novice

In the Novice division we have 42 players. Advised to have 3 teams as there may be another
2 players dropping out.

PeeWee

- We are in a situation where we have had two more players withdrawing from the PeeWee division. This has put our numbers low to have four teams in our association. The teams would be very small and would have to use their affiliates.
- We had 54 registered players. 5 of the players are goalies. That leaves 49 players. Minus 2 players that have decided not to play which leaves us with 47 remaining skaters.
- o Option 1 would be:
 - 15 Players to AA Team + 1 Goalie
 - 16 Skaters to A Team + 2 Goalies
 - 16 Skaters to B Team + 2 Goalies
- Option 2 would be:
 - 13 Players to AA Team + 1 Goalie
 - 12 Players to A Team + 2 Goalies
 - 11 Players to B Team + 1 Goalie
 - 11 Players to C Team + 1 Goalie
- Another decision if we decide on option 2 would be how we place our teams:

- Brent Talsma made motion to have an AA, A, B, C to support team affiliation within the LMH PeeWee division. Lori McCrea seconded the motion. Voted and 17 in favor. 2 Abstained. Passed.
