
EXECUTIVE COMMITTEE MEETING MINUTES

- GICs: \$33,650
- GICs have been moved as follows:
 - \$5,000 in a 15-month non-redeemable @ 4.65%
 - \$5,050 in a 15-month non-redeemable @ 4.65%
 - o \$23,600 in 3-year rate builder, current return 3.5%, builds over next two years
- Provincials are paid for four teams, missing some Session 3 fees and Championship fees, but
 I have paid BGL for our part.
- Waiting on reimbursement from BGL for travel fees to Ft Mac for two teams yet.
 - Carmen has emailed the treasurer at BGL should be coming soon.

4.6. ICE ALLOCATOR – Amanda Hatto

- Blackfalds will be increasing their ice rates next season.
 - We will receive a 15% discount, making the new increase total \$153/hour (up from \$140/hour). Comparable - Lacombe currently charge \$105/hour and is expected to raise their rates to \$110-\$115.
 - Discussion around petitioning the Town of Blackfalds for local rates, as many players are Lacombe County and Blackfalds players (Nicole brought information from the county, as Lacombe county funds operating and capital expenses for the Eagle Centre).
 - Amanda would like to have this cost down to \$120/hour and highlight our Dual Ice
 Surface project support.
- Come Try Ringette hosted in Blackfalds after the U12B Championship.
- Practices and Level Up practices have been scheduled.
 - Will include coaches to also participate in level-up, to help them prepare for next season.

4.7. REFEREE ALLOCATOR - Sherri O'Muir


- Done with all league games.

 - There have been several complaints from both spectators and coaches. This is unacceptable and will be brought up at the AGM.
- Looking at adding refs to the U10-1/U10-2 games to get them on the ice and gain experience earlier.

• U12B affiliation issue – there was a misinterpretation of the policy (specifically regarding goalies), but this has been cleared up.



7. UNFINISHED/NEW BUSINESS

7.1. 2023/24 Tournament Discussion

- The City has agreed to give us a second tournament weekend to split up the tournament (which will help with scheduling, refs, volunteers, etc.)
 - o November 24-26
 - December 8-10 (tentative)
- We will need to figure out how to split up the levels at each tournament and may look at changing how the Tournament Committee is set up:
 - One Tournament Director, with reps from each level to help organize each tournament (vs. the responsibility landing on a couple of individuals to plan).

ACTION: Amanda will compare the tentative date (December 8) to ensure it doesn't conflict with any hockey/key ringette tournaments.

7.2. Spirit Club (From Louise Rellis)

- The idea around a Spirit Club was to have the teams foster a sense of community and encourage our players to grow community cohesion in the communities of Blackfalds and Lacombe and each additional community our players are from, should they wish.
 - Each year, teams selected events/activities that support community organizations to sponsor.
 - The original request included more fundraising activities, but the committee decided it would be too onerous/confusing, as the fundraising would be split between a charity and the association.
- The Spirit Club would involve organizing opportunities to connect with and give back to community members and organizations while also looking at developing fundraising opportunities for the Association and community non-profit organizations collectively.
- There will not be an age range; it will be open to all committed to involvement.

ACTION: The Committee supported this request, with the removal of extra fundraising (as noted above), but perhaps looking at activities like:

- Snow shovelling, mitten tree/sock tree, monthly food bank drive/theme, etc.

This will be announced at the BANQUET portion of the AGM, and an email will be sent out later in the fall to the association base. Nicole Plewis offered to work with Louise on this initiative.

7.3. Affiliation Policy (From Sherri O'Muir)

- Following some confusion surrounding affiliation uses/limits/decisions/etc., Sherri O'Muir looked at the Affiliation Policy and made some changes to help clarify for future years.
- She identified that it is essential to have discussions, especially with newer/younger teams and coaches so that they understand the intent of and process for affiliation.
- Ringette Alberta has a policy in place, but this is an overarching policy. We will look at customizing for our association.
- Shelley Vickery recommended limits on specific players being selected.
 - Coaches are asked to rotate through the affiliates and not rely on 1-2 specific players.
 This provides an equal opportunity for all eligible affiliates.

ACTION: Sherri will review this policy and include comments from the discussion to finalize the changes and for official approval of the reviewed Affiliation Policy.
