  - Tiering meeting with Ringette Alberta on August 29
  - Looking for goalies for U14 and U16. Looking for players for U19
    - Recommend reaching out to Ringette Alberta to have these advertised on their social media channels
    - o Have discussed the U19 numbers with Red Deer Ringette
    - Looking at options for U19. Currently there is not U19 C league. There are
      options to play with CABO or that the BGL B league will be split in two based on
      skill level
  - Donated \$735 to KidSport from the used equipment sale
  - Black Gold League (BGL) is discussing a Weather Policy Change. It remains status quo for the time being

### c. **REGISTRAR** - Gwen Martin

- Current Registration is at 140 players
  - o U6 12 players
  - U10 27 players (3 teams)
  - U12 32 players (2 teams)
  - U14 24 players (2 teams)
  - U16 24 players (2 teams)
  - U19 19 players (2 teams)
- U10, U12 and Open C tournaments sanctioned. Fees are owing
- November 29 U14, U16 and U19 tournament Ringette Alberta is asking us to confirm that we have our own refs as there is already three tournaments that weekend. Last year we were able to do it primarily with our own refs however, it is expected that refs would be going to some of the other tournaments that weekend. Switching the tournament weekends likely results in issues with high school exams. No other tournament weekends were offered to Lacombe Ringette by the City of Lacombe

# e. TREASURER – Raelyn Buksa

- Registration income is down about \$8,000 from where we were at this time last year
- Black Gold League still has money owing. Looking into this

## f. ICE ALLOCATOR - Amanda Hatto

- September schedule is out
  - September 21 game evaluation times are still being worked on because The City is working to have the back ice in that weekend. Times will be provided as soon as they are available
- We got more practice ice in Blackfalds Monday 8:30-9:30 p.m. (closed every statutory holiday)
- Sting did not want any of the Sunday ice this year so we got back Sunday ice
- In the process of trying to organize some power skating and clinics
- Pan Continental Curling Championships is being hosted at the Lacombe arena
  - o Losing front ice on October 20
  - If everything goes according to plan we will still have the back ice until November 3
  - o No ice November 3 6 (this is fully dependent on process).
  - o Ice during curling tournament (October 27 November 2) will look a lot like September ice but on back ice. We will get a portion of practice ice and game ice. BGL will try to schedule away games during this time (this may result is more away games in the first half of the season and more home games in the second half of the season). Ice Allocator will try to keep things fair but we are

subject to BGL scheduling. Trips to Fort McMurray have been recommended for this time period as weather should be good and home ice is not an option. Lacombe Ringette has requested that two teams go to Fort McMurray at the same time in order to share a bus

- Currently Fort McMurray as the following teams U10-3, two U1 B, U14A (hosting provincials), U16B and working on U19B (hosting provincials)
- When teams are created the Directors will be asked to send a reminder regarding the changes to ice due to the curling tournament

# i. Update on ice availability in Ponoka

- Ponoka will not provide ice until their local user groups have declared their ice needs. Ponoka has put ringette lines on both of their ice surfaces this year

# g. REFEREE ALLOCATOR - Sherry O'Muir

- Sherry O'Muir and Shelley Vickery met with Red Deer Ringette to talk about changes to reimbursement for referee clinics. We have more young refs than what we have capacity to use in Zone 4.
  - Discussed calculating the cost invested in Referee training and dividing that by the number of teams that an association has. This provides a per team training cost for referees. These funds could be pooled to be used to pay for referee training for players from ringette associations in Central Alberta.
  - Considering an application process for new referees as there isn't enough game availability for all referees to get game experience. This would also consider the potential referees availability.
- Will do first stripes junior reffing program again this year. There is no cost for this course

## MOTION: Moved by Sherri O'Muir to

- Establish an application process for Level 1 referees
- That reimbursement for Level 1 referees will not be provided until a ref has reffed 5 games
- To pursue the proposal to develop a calculation to determine per team referee training costs and pool funds per team from Lacombe Ringette, Red Deer Ringette and Central Alberta AA Ringette to be utilized to pay for referee training for Zone 4 referees

### h. CASINO / FUNDRAISING - Megan Bateman

- Would like Coaching Directo to ensure that teams are aware that a team Fundraising Coordinator is duly responsible for team and association fundraising
- Barb Taylor will look into Bingo fundraising options
- The Pan Continental Curling Championships Committee has offered Lacombe Ringette two fundraising opportunities
  - Booth space in the arena lobby along with a bake sale with cooking to be conducted in compliance with Alberta Public Health. Minimum 3 – 4 hours
  - o Garbage and recycling removal after every draw in exchange for recyclables

These options were declined as it is expected that teams will be making efforts to be out of town that weekend and it will be difficult to get required volunteers

- Will be doing the raffle again this season
- Casino will be in 2025

- Small nets in Clive were discussed and it was determined the nets will stay in Clive for the time being until teams and ice locations are determined
- Shot clocks in Blackfalds have issues as they are finnicky and were calibrated with the score clock. Lacombe Ringette does not have another set of calibrated shot clocks.
- Will do sign up sheets for the equipment
- Require numbers for each age group to determine if there are enough jerseys

**ACTION:** Brett Miller to research the cost of new shot clocks and calibration.
