#### b. ICE ALLOCATOR - Amanda Hatto

- Ice was submitted to Black Gold League (BGL). We could not submit the number of ice times required by the league due to ice outages and availability. BGL had been already informed and is willing to work with the Association
  - o Option 1 Utilize the ice times as submitted
  - Option 2 Red Deer had additional ice which Lacombe Ringette Association may be able to access ice available from
  - Option 3 Play more games out of town in the first part of the season
- Full schedule is not provided until the back ice is ready for use
- Will talk with coaches regarding the availability of morning practices as we are able to cancel morning practices if sufficient notice is provided to The City
- The Pan Continental Curling Championship will impact ice so schedules will not be routine in October. Will try to work with coaches on the scheduling
- Have booked power skating for the entire season
  - o Dates will be released once ice is confirmed. First one is October 6
  - o Power skating Instructor will be Val Norrie
  - o Waiting on confirmation if coaches will be required on ice
  - o Schedule and ages have been set by instructor and can not be changed
  - Hoping for higher attendance than previous years as this is a high cost and large offering to the organization
  - o BGL schedule can not be controlled so there will be conflicts for teams

## c. REFEREE ALLOCATOR - Sherri O'Muir

- Level1 Ref Clinic will be in October, first or second weekend
- Ref applications will be going out soon
- First stripes program will be offered this year
- Ref Rooms and flex rooms were switched this summer and the new rooms are not sufficient for the number of refs. The switch was made to accommodate female athletes in other sports. Lacombe Ringette was not consulted
- No information has been received from Red Deer Ringette regarding pooling costs for training referees. If other association do not join consolidate with us, we will continue to pay for the costs of referee training for athletes registered with Lacombe Ringette
