4.6. ICE ALLOCATOR - Amanda Hatto

- Session 3 ice was sent in to BGL. Will get it back weekend by weekend (depending on whether it's picked up or not). This could result in last minute practices being assigned to teams.
- U12A is hosting the championships in Red Deer on March 8, 9, & 10.
 - o Ice has been secured.

- Could combine with Red Deer to create a true U16A/U19A team, allowing Zone 4 to be more competitive with the larger city teams.
- o This will be discussed more with parents at the AGM

5.4. ZONE 5 DIRECTORS – Cheryl Talma\Lori Unger

Fort MacMurray cancellation\issues

- o if the ice wasn't used after the last cancellation (due to cold weather), Fort MacMurray will be billed for it. Lacombe U16B did take the Sunday night slot for a practice.
- Want to bring up that there are supposed to be 2 levels of teams going up at a time to make the trip to Fort Mac worth it (or have them play several different teams here, if they are travelling - like Lacombe and Red Deer or Lacombe and an Edmonton-area team).

• U12 Championships

- Central Alberta keeps being pressured to host these. Cheryl will bring up the idea of creating a set schedule for U12A hosting, and rotating through communities, so it doesn't continue to land on the same one or two associations (costs, volunteers, scheduling, etc).
- This would be set up for several years, so that associations can plan better to host when it's their turn.

6. COMMITTEE REPORTS

6.1. TOURNAMENT REP – Brett Miller/Lori Unger/Jeremy Olthof

- No one attended.
- Committee discussed the need for a better structure to help make our tournaments a success. This might mean bringing together a sub-committee OR having the reps from each team to play a larger role in planning.

 - Vice President to deal with sanctioning this MUST be done in September, otherwise getting teams will be difficult!

7.2. Ringette Night Feedback (Shelley Leslie)

- Due to increased food costs, should we focus on using the concession downstairs or making Ringette Night more about the experience/prizes/kids.
 - Team to organize their own food.
- Chelsea has a plan to make things better, and will implement those ideas next year.

7.3. Goalie Development / Clinics (Deb Martin)

- Deb expressed concerns about the lack of support for goalies.
 - o In 2023-24, there has one been one session for the kids to attend
 - Goalies aren't being focused on during practices, and coaches need better training/direction/plans.
 - No training on angles, slides, etc. means that Lacombe goalies are falling behind or feeling unsupported.
 - We need to promote the goalie position to younger kids, and we need coaches to promote goalie training.

MOTION: Shelley Vickery moves to create a Goalie Director position for the LRA Executive, starting for the 2024-25 season. This position would help develop a goalie program for the Lacombe Ringette Association, and would help promote coach training
