  - Facility Safety Restrictions: lobby
  - Make sure we are not spending time in the lobby
  - New lane and caution tape
  - Staff will not be enforcing this, just sending the association an email
  - Players can come to the building 30 min prior to ice time
  - Spectators can come in the building 10 min prior to start time, this pertains to games
  - If we notice, we are getting to capacity they are asking that we close the door to the lobby
  - It is up to the arena staff if they will open up a dressing room from coaches as they will have to clean it
  - If you are using the small dressing room on the back ice please wear masks, and make sure only 1 cohort of coaches are in there at one time
  - Coaches and players are required to wear masks in the building and dressing room
  - The facility suggests that you remain socially distanced and wear a mask, but it is not mandatory
