- a) Baseball Alberta Zone 7 Representative Doug Bassett:
- The AGM will be Nov 23. BA board is quite large (8 zones plus 500+ associations), so working on reducing the size of the board.
- No huge issues. Thanks to the host sites in our zone.
- Lunch and learns and other info on the BA website can view the videos.
- Our zone and league is doing very well.
- Change of name from House League to Short Season (sounds more competitive).
- Today is the deadline to submit nominations for awards. Submit online.

b) Softball Alberta – Zone 7 Representative Sharon Earl:

- What SBA would like to encourage at C and D level is coaches to get certified. I find that a
 team wants to entered provincials and can't because they are not certified and can't find
 anyone who is available.
- This process should be started in January by contacting SA to host a clinic. The earlier you start booking, the better chance of getting a clinic in your area.
- SBA has their AGM in 3 weeks. If anyone has some concerns regarding provincials, etc please have them give me a call
- SBA is also setting up a tiering system for 2025 for the U17, U19, A/B Categories and possible U15
- More info after the AGM. Will look at C/D divisions in 2026.

 Concerns about not all teams being accepted to provincials and timing of provincials.
