## ALBERTA SOCCER ASSOCIATION

## Code of Conduct

1) Members have an obligation not only to abide by the By-Laws and Rules and Regulations of the Association, but also to act in a manner that displays their commitment to the principles and intent of the By-Laws and Rules and Regulations.
2) All Members should expect to be treated fairly in all matters. Members shall not discriminate against other Members by means of different, unequal, or inconsistent treatment applied to individual members.
3) Individuals shall not provide the potential for, or the appearance of, an opportunity for benefit, wrongdoing, or inappropriate conduct. It is important to emphasize that conflict of interest relates to the potential for wrongdoing as well as actual or intended wrongdoing.
4) Information or data entrusted to Members for use in their capacity or position shall not be disclosed or used in a manner that may cause embarrassment to the Association, or that betrays a trust or confidence.
5) Members shall at all times exhibit behavior that maintains the Association's reputation and shall at no time harm or hinder the Association or its ability to represent the sport.
6) No Member shall harass another Member by actions that include, but are not limited to, unwelcome remarks, invitations, requests, gestures, or physical contact that, whether indirect or explicit, has the purpose or effect of humiliating, interfering with, or creating an intimidating situation for that other Member. Harassment shall be considered inappropriate behavior, be it ethnic, religious, or sexual in nature.
7) The interaction or involvement of Members under the jurisdiction of the Association shall not result in threats, intimidation, or inflicted physical distress between such Members, whether implied or explicit.

All rules and "Laws of the Game" from FIFA will be adhered to except as set out in the following Championship Rules.

## 1. PROVISIONAL RULES

1.1. These Rules shall apply to all Provincial Championships. Any variances for specific competitions will be as noted in these Rules.
1.2. The Alberta Soccer Competitions Committee is responsible for the management and control of all Provincial Championships.
1.3. These Rules are subject to the Alberta Soccer Bylaws, Code of Conduct, and the General Regulations and Policies.
1.4. Within the constraints of Rule 1.3, the Competitions Committee may make temporary rules to govern specific situations not otherwise provided for within this rule book and in the interest of fair play.
1.5. The Competitions Committee will be empowered to move any event to a location more suitable to the contesting teams or combine locations for certain age groups of the same level where an insufficient number of teams are competing.
1.6. The Competitions Committee shall appoint to each competition an Alberta Soccer Representative, who will establish a three (3) person Discipline Committee ("the Competition Discipline Committee"). The Alberta Soccer Representative and the Competition Discipline Committee will act as an extension of the Competitions Committee. All decisions reached by the Competition Discipline Committee on any competition-related matter will be final.
1.7. All dates and deadlines indicated in this rule book are intended for District use. Districts and leagues are free to set earlier deadlines to which their teams are expected to adhere to.
1.8. In the event of a discrepancy between the current Alberta Soccer rule book and the current Canada Soccer Rules and Regulations for Regional / National Championships, the Canada Soccer Rules and Regulations will be followed. This only applies to teams competing in Provincial Championship leading to Regional/National Championships.

## 2. PROVINCIAL DECLARATIONS

2.1. The final deadline for Districts to indicate their entries for the current Indoor Provincial Championships in the manner prescribed by the Alberta Soccer office is as per the published dates.
2.2. The final deadline for Districts to indicate their entries for the current Outdoor Provincial Championships in the manner prescribed by the Alberta Soccer office is as per the published dates:
2.3. The district will be assessed a fee per late declaration and the Competitions Committee will determine whether the late entry is to be accepted or denied.
2.4. In circumstances where a championship does not have a full complement of teams, the Manager of Competitions may invite teams from any district to participate in the Provincial Championships. Declaration fees for such additional declarations will be assessed on a case-by-case basis.
2.4.1. Priority for any additional declarations will be based on the declaration fee, geographic distance from the host location, and the number of declarations already allocated.
2.4.2. Except for championships leading to a National Championship, Provincial Championships will not be run for categories where there are fewer than:
2.4.2.1.four (4) declarations received by the Declaration Deadline unless the declaring district agrees to continue with the Championships.
2.4.2.2.two (2) Districts declared by the Declaration Deadline unless the declaring districts agrees to continue with the Championships.
2.5. Districts will be invoiced for their Provincial Championships declarations as per their declaration form. There will be no refund for a team that withdraws prior to the championships.
2.6. If the location of the Provincial Championships is confirmed or changed after the Declaration Deadline, all competing Districts will be given the opportunity to adjust their Declarations without penalty.
2.7. Each District will be allowed to declare one (1) Youth team per Youth category
2.7.1. One (1) additional declaration will be allowed for each:
2.7.1.1. District that exceeds 5,000 registered Youth players in the previous season.
2.7.1.2. District hosting the Provincial Championship.
2.7.2. A District with more than 5,000 registered Youth players that are hosting the Provincial Championship will be entitled to up to three (3) declarations.
2.8. No Division, league, or tournament leading to the Provincial Championships can qualify teams into more than two (2) different Provincial Championships of the same age.
2.9. Except for leagues structured by age, no team competing in a division, league, or tournament leading to more than one Provincial Championship can solely declare for the lowest available level of competition.
2.10. Districts are expected to provide a contact person for each Provincial weekend in which they have teams competing who will be available to address any roster or player eligibility issues.
2.11. In Outdoor Championships only, teams from CMSA EMSA, \& EIYSA cannot compete in the Tier IV Rural Provincial Championships.
2.12. In Outdoor Championships only, Rural Districts may declare to compete in both the Tier IV Rural and Tier IV City Provincial Championships. The same team may not compete in both Provincial Championships. No players may compete in both the Tier IV Rural and Tier IV City Provincial Championships.
2.13. For Tier 1 to Nationals, the total number of teams will be determined by the Competitions Committee following the declaration deadline.
2.13.1. All teams within their leagues must play an equal number of games as they are vying for a spot in Provincials through league standings unless approved by the Competitions Committee.
2.13.2. All teams in these leagues would vie for the spots allocated to that league.
2.13.3. The Host District for Provincials will receive one guaranteed declaration. For the purposes of this Rule, EIYSA and EMSA are considered separate districts.
2.13.4. Districts not participating in a Tier 1 league, must participate in a minimum of two (2) ASA-approved Tier 1 Tournaments prior to July 31 of the participating year.
2.13.4.1. The schedule (including opponents) and results (if completed) must be provided to the ASA for review by the ASA Competitions Committee to demonstrate that the team is competitive at the Tier 1 level. This information is due by the declaration deadline.

## 3. TEAM ELIGIBILITY

3.1. Any team affiliated with their District Association and in good standing will be eligible to participate in any Provincial Championship under the jurisdiction of Alberta Soccer, subject to declaration limits set out in this rule book.
3.2. No registered Youth team will be eligible to compete in more than one (1) Provincial Championship in any one (1) season.
3.3. A team must have participated in at least six (6) games against equal or higher-level competition during the season to compete in Provincials at that level. If the games are against higher-level competition, their outcome must demonstrate that the lower level is the more appropriate category of play.
3.3.1. The Competitions Committee may accept or decline any declaration.
3.4. Youth teams are permitted to play up an age group, including playing in a Senior league, for developmental purposes and return to their original age for the Provincial Championships.
3.4.1. Teams may only declare for the same tier of play or higher than that which they were playing in an older age group upon returning to their original age category.
3.5. All other teams must compete in the Provincial Championships at the same level at which they compete throughout the playing season.
3.6. High School teams in Alberta may not participate in any sanctioned Alberta Soccer league or be part of any Alberta Soccer clubs even under the guise of Alberta Soccer District Club teams appearing to have no direct affiliation with High Schools. Players may play for both a High School and a club team.
3.7. No Alberta Soccer registered team assembled by an unsanctioned academy by its own name or under any other guise will be permitted to participate in any Alberta Soccer league or club or participate in any Alberta Soccer Championship.
3.8. The District will provide a certified team roster for each team participating in a Provincial Championship in the manner prescribed by Alberta Soccer by the roster submission deadline.
3.9. A District that places a team in another District's league, with the consent of both Districts, on a non-exhibition basis (where teams play for a Provincial berth) does not lose its right to declare a team for the same age/gender and category of Provincial Championship. The team playing for a Provincial berth in another District's league cannot return to its own District of domicile to challenge for that berth.
3.9.1. The home district can allow the district where they are playing to use their declarations in addition to the ones they are allotted. This consent must be done in writing by the start of each season.
3.10. A District that places a team in another District's league, with the consent of both Districts, on an exhibition basis may use only its own District's berth to declare for Provincial Championships and not that of any other District.
3.11. Tier I teams are not eligible to compete in Tier II, III, or IV Provincial Championships. When a District is running a Tier I/II split league, it is the District's responsibility to submit to the Competitions Committee a description of the league and how the Provincial Representatives are determined for approval no later than the declaration deadline.
3.12. To be eligible to compete in a Provincial Championship leading to a National Championship, a team must have a minimum of seventeen (17) registered players who are eligible to participate in the Provincial Championship.

## 4. PLAYER ELIGIBILITY

4.1. Players must be registered with Alberta Soccer fourteen (14) days prior to taking part in a Provincial or Regional Championship. All players and teams are subject to Alberta Soccer's roster and transfer deadlines.
4.1.1. To be eligible for a Provincial Championship leading to a Canada Soccer National Championship, players must be registered with Alberta Soccer by July 31st of the current year.
4.2. Registrations will be valid for one (1) season.
4.3. Players in age categories who reach the limiting age after the first day of January will continue to be eligible to play in that age category for the remainder of the playing season.
4.3.1. U19: Players under nineteen (19) years of age before January $1^{\text {st }}$ of the current year.
4.3.2. U17: Players under seventeen (17) years of age before January $1^{\text {st }}$ of the current year.
4.3.3. U15: Players under fifteen (15) years of age before January $1^{\text {st }}$ of the current year.
4.3.4. U13: Players under thirteen (13) years of age before January $1^{\text {st }}$ of the current year.
4.4. Any team that includes a player who is over the age limit as defined in 4.3 will forfeit all games concerned and will be subject to disciplinary action.
4.5. Only players listed on the District certified roster will be considered eligible to participate in the Provincial Championships.
4.6. A Youth player may register with and play for both a Youth team and a Senior team and maintain their eligibility to compete in both Youth and Senior Championships in accordance with their district registration deadlines.
4.7. A registered Youth player will not be considered cup-tied for a Provincial Championships to any team if they have participated as a trialist prior to having registered with a Senior team.
4.8. Eligible players properly registered with both a Youth and a Senior team may compete in one (1) Youth Provincial Championship and one (1) Senior Provincial Championship.
4.9. Every player at all Provincial Championships must present a District approved ID or valid government photo ID, $s$ that will be accepted by the referee prior to participating in the game. The burden of proof of eligibility will rest with the player. All player IDs must have a photo.
4.10. A player who has been a professional or a non-amateur player will not be eligible to compete in any Provincial or Canada Soccer Championship unless properly reinstated as an amateur player by the roster deadline of the championship they are wishing to compete.
4.11. Any registered Alberta Youth Soccer League player who has played 5 or more games in the AYSL is not eligible to participate in any Provincial Championship outside of the AYSL.
4.12. As per Canada Soccer, a Youth player who has signed for both a Youth team and a Senior team, and who qualifies for both the Youth and Senior National Championships must attend the Youth National Championships.
4.13. No player can compete in more than one (1) Youth Provincial Championship, except as outlined below:
4.13.1. Rural players who compete in a Tier IV Rural Provincial Championship will not be considered cup-tied if their District wishes to form a legally declared Tier I, II, or III team. Such players will be considered eligible to compete in Tier I, II, or III Provincial Championships, but not more than one (1).
4.13.2. Rural players who declare to compete in Tier II or III Provincial Championships will not be considered cuptied if their District wishes to form a legally declared Tier I team.
4.14. As per Canada Soccer Rules and Regulations for National Championships, all players participating in a Provincial Championship leading to a National Championship must be a Canadian citizen, Permanent Resident, or a Protected Person.
4.14.1. Each player must present proof of eligibility or CSA exemption documentation to Alberta Soccer by the deadline set by Canada Soccer. Players from whom proof has not been presented are not eligible to participate. Proof of eligibility is as follows:
4.14.1.1. Canadian Citizen - valid passport or birth certificate.
4.14.1.2. Permanent Resident - valid permanent resident card; or proof of permanent residency as provided by the Government of Canada.
4.14.1.3. Protected Person - documents as provided by the Government of Canada.
4.14.1.4. Or legible copies of these documents.
4.14.1.5. CSA Exemption documentation

## 5. TRANSFER OF PLAYERS

5.1. Players transferring laterally or to a lower level of play will not be considered cup-tied if the transfer takes place prior to their fifth league game, subject to local rules.
5.2. Players transferring to a higher level of play will not be considered cup-tied if such transfer is completed by the published dates
5.3. Prior to the transfer deadline a player from the same club, can transfer to the higher club team, in the event the lower tier team did not qualify for provincials.

## 6. REPLACEMENT PLAYERS

6.1. A team may request, through their District, special permission to replace players after the player transfer deadline, under the following guidelines:
6.2. Players may only be replaced due to injury, illness, or family commitments and Alberta Soccer will request proof of such prior to approving the replacement.
6.3. All replacement players, and replacement player requests, are approved by the team's District Association, authorized by Alberta Soccer.
6.4. All replacement players must be clearly indicated on the Alberta Soccer roster.
6.4.1. All replacement players must have a Replacement Player Form submitted with the roster.
6.5. All replacement players must come from within your District Association.
6.5.1. Replacement players cannot increase the roster above the original number of registered players. A replacement player must replace a registered member of the team.
6.5.1.1. Youth teams can only request replacement players if their roster is depleted to sixteen (16) players or less and may only use replacement players to bring their roster back up to seventeen (17) players.
6.5.1.1.1. Teams are eligible for a maximum of four (4) replacement players.
6.5.2. Replacement players must come from the team's club system if such a system is in place.
6.5.3. If the season is incomplete, any replacement player must have the consent of the team/club for which they play.
6.5.4. Teams cannot choose replacement players from a team that has qualified for a Provincial Championship.
6.5.5. Replacement players must come from a lower level of competition (see Appendix A), except as noted below.
6.5.6. Teams attending Tier IV Rural Provincials may pick up a maximum of two (2) players from another Tier IV team of the same age, subject to Alberta Soccer cup tied rules.
6.5.7. Where there is no lower-level team to draw replacement players from Tier I, II, III, and Tier IV teams, may apply through their District Association to the ASA Competitions Committee, for special dispensation to use players from the same level of play.
6.6. Once a player has been replaced, the player cannot participate in the Provincial Championships.
6.7. A team may apply through their District Association to the Competitions Committee to add replacement players to their roster after the roster submission deadline when:
6.7.1. The team's goalkeeper became ill or injured after the roster submission deadline, but before the start of the Provincial Championships.

## 7. TEAM OFFICIALS

7.1. A maximum of four (4) non-playing personnel may be listed on the team's official roster and are the only team personnel allowed on the team bench during the Provincial Championships.
7.1.1. All teams must adhere to the Rule of Two at all times.
7.1.2. All teams with Youth female members must have an adult female on the official roster and on the bench at all times during the games. All teams with Youth male members must have an adult male on the official roster and on the bench at all times during the games.
7.1.3. Teams may name an alternate team official who may replace one of the initial four (4) in the case of an absence.
7.1.4. Injured players may sit on the bench dressed with the permission of the Alberta Soccer Competitions Committee Representative
7.2. All team officials must have a District approved Photo ID Card or valid government photo ID and present this to the referee prior to participating in each game. The burden of proof will rest with the team official.
7.3. All team officials listed on a Provincial Championship roster are required to obtain Criminal Record Check Clearance, within the last three (3) years from the start of the Provincial Championship.
7.4. One team official from each team involved in the Provincial Championships must fulfill the coaching requirements for the appropriate level as per the chart below. This qualified team official must be present at each game of the Provincial Championships:

Coaching requirements expiring March 31, 2025

| Competition | Coaching Requirement |

| U13 Tier 1 | Soccer For Life Trained OR Higher |
| U15+, Tiers 2-4 | Soccer For Life Trained OR Higher |
| U13, Tiers 2-4 | Learn to Train $\underline{\text { OR Soccer For Life } \underline{\text { OR }}}$ |

Coaching requirements will be implemented April 1, 2025

| U13+Tiers 2-4 | Soccer For Life Trained OR Higher |

7.4.1. In the event of non-compliance with any team official regulations, the Competitions Committee will decide the appropriate course of action.
7.5. Coaches can only coach one (1) team within the same tier and age group of a Provincial Championship.

## 8. TEAM ROSTERS

8.1 By submitting any Provincial Roster, the District Association is certifying that all players are in good standing and properly registered, that all coaches and team officials are qualified, and Police Record Check cleared, and that the team is properly registered and has fulfilled the necessary requirements to compete in the Provincial Championships.
8.2 District Associations must certify all team rosters and submit them in the manner prescribed by Alberta Soccer by the published deadlines.
8.3 A team roster shall not exceed twenty (20) players and a team may dress all twenty (20) for any game.
8.4 No roster changes will be accepted within three (3) business days of the start of the Provincial Championships. In extenuating circumstances, changes may be made with the approval from the Competitions Committee.

## 9. FINANCIAL RESPONSIBILITIES

9.1 Teams competing in Provincial Championships are responsible for travel, accommodation and other similar expenditures incurred.
9.2 Teams competing at a Canada Soccer Championship are responsible for travel, accommodation, and other similar expenditures incurred.
9.2.1 Teams will receive financial assistance for these expenditures as established annually by Alberta Soccer and Canada Soccer.

## 10. EQUIPMENT AND UNIFORMS

10.1 When the colours of competing teams are similar, home teams shall use alternate colors. Each team must have a set of pinnies with them at each game if they do not have alternate jerseys
10.1.1 Goalkeepers must carry three (3) pairs of socks that differ in colour. At least one (1) pair must be a colour other than black, white, or navy.
10.2 All jerseys must be clearly numbered. The number of the jersey worn by a player must correspond to the number listed with the player's name on the game sheet.
10.3 Visible undergarments such as compression shorts or long-sleeve tops may be worn.
10.4 In a Provincial Championship leading to a National Championship:
10.4.1 Undershirts must be the same colour of the main colour of the shirt sleeve; undershorts/tights must be the same colour as the main colour of the shorts of the lowest part of the shorts - players of the same team must wear the same colour.
10.4.2 Where tape or similar material is applied externally to a sock it shall be the same colour as the part of the sock to which it is applied.
10.4.3 Teams must have two pairs of socks, which are different colors.
10.4.4 Substitute and substituted players must have a pinnie which is different from the players on the field. Nonplaying personnel must be distinguishable from the players on the field. In some circumstances, nonplaying personnel will be requested to wear a pinnie.

## 11. JEWELRY AND BRACES

11.1 FIFA approved modern protective equipment such as headgear, facemasks, and knee and arm protectors made of soft, lightweight, padded material are permitted. If any question arises as to whether a piece of equipment can be worn, it may be presented to the head official for approval.
11.2 No Jewelry is permitted.

## 12. TOURNAMENT CHECK-IN

12.1 At least one representative from each team competing in the Provincial Championships must:
12.1.1 Check in with the Alberta Soccer Representative prior to the team participating in their first game;
12.1.2 Complete and submit a Team Information Sheet_in the manner prescribed by Alberta Soccer; and
12.1.3 Attend the pre-championship meeting as scheduled, unless alternate arrangements are made before the championship begins.
12.1.4 Failure to attend pre-championship meeting will eliminate the team's right to protest or appeal any decision made by the Alberta Soccer Representative during the championship.

## 13. SCHEDULES AND FORMATS

13.1 The format for all championships will be determined by the Manager of Competitions following a review of the declarations received.
13.2 Team seeding shall be determined by the Manager of Competitions by previous year's standings.
13.3 Where there are two (2) or more groups of three (3), or two (2) or more groups of four (4) crossing over, no two (2) teams from the same District will be seeded into the same group whenever feasible.
13.4 The Championships not leading to Nationals may start on Friday.
13.5 All teams competing will play a minimum of three (3) games.
13.6 All schedules, to the extent possible, will be determined with a minimum of three (3) hours of rest between scheduled games.
13.7 In the event a team drops out of a Championship and no replacement team can be found, the changes to the groups, format, and schedule shall be determined by the Manager of Competitions and duly communicated to the affected Districts.
13.8 Seeding for the Tier 1 Championships, leading to a National Championships will be determined by the Manager of Competitions.
13.8.1 Teams competing at a Provincial Championship leading to a National Championship will not play more than one (1) game per day.
13.8.2 Tier 1 to Nationals will start on Thursday

## 14. GAME DURATION AND BALL SIZES

14.1 The duration of an outdoor match will be as follows:

| Age Group | Game Duration | Extra Time (if required) |
| :--- | :--- | :--- |
| U13 and U15 | Two 35-minute halves | Two 10-minute halves |
| U17 and U19 | Two 40-minute halves | Two 10-minute halves |

14.2 Extra time will only be played when the following games are tied at the end of regulation time:
14.2.1 Gold Medal Games.
14.2.2 Games in championships leading to a National Championships requiring a result where advancing to a gold-medal final is still possible. If the game is still tied at the end of extra time, the winner will be determined through the taking of kicks from the penalty mark in accordance with the FIFA Laws of the Game.
14.3 All indoor games will be $2 \times 25$-minute halves.
14.4 For all other games that require a result and are tied at the end of regulation time, the winner will be determined through the taking of kicks from the penalty mark in accordance with the FIFA Laws of the Game or the Rules of Indoor Soccer (whichever is applicable)
14.5 It is the responsibility of the home team to provide two (2) size 5, FIFA-approved game balls for each game.
14.5.1 Match balls will be provided by Alberta Soccer for all games in all Provincial championships leading to National championships.

15.2.1.1. Tiers 3 \& 4 Boarded -6 v 6 (5 players and 1 goal keeper)
15.2.1.2. Tiers $1 \& 2$ Non-Boarded - 7 v 7 ( 6 players and 1 goal keeper) with no offsides
15.2.2. Outdoor
15.2.2.1. U13-9 v 9 (to be implemented 2025)
15.2.2.1.1. U13-11 v 11 outdoor 2024
15.2.2.2. U15 - U19 11 v 11

## 16. SUBSTITUTIONS

16.1 All Provincial Championships will allow for unlimited substitutions.

## 17. TIE-BREAKING PROCEDURE

17.1 Three (3) points will be awarded for a win and one (1) point for a tie. Standings will be determined by the total points won at the completion of the round-robin.
17.2 In any three (3) team round robin, whether part or whole of the championship, the third game played in each pool will be played to a decision if the team not participating has zero (0) points, has been suspended or has withdrawn.
17.2.1 The team that eventually loses the game will still be awarded one (1) point for the tie. For the purposes of Goals For and Goals Against, the score at the end of regulation time will be used.
17.3 In any three (3) team round robin, when the first game ends in a tie, not completed due to weather or scheduling constraints. For scheduling purposes, the winner will be determined by a coin toss. The coin toss will be completed by the Alberta Soccer Representative. A team representative from each team will be invited to witness the coin toss. Each team will receive one point for the tie, and for the purposes of Goals For and Goals Against, the score at the end of regulation time will be used.
17.4 The following criteria will be used to determine the final standings if two (2) or more teams have an equal number of points at the end of the round-robin. This tie-breaking procedure must be carried through in its entirety; no tie-breaking rule will be used twice:
17.4.1 Greater number of points in matches between the tied teams
17.4.2 Greater goal difference in matches between the teams tied (if more than two (2) teams are tied);
17.4.3 Greater goal difference in all group matches;
17.4.4 Greatest number of goals scored in all group matches;
17.4.5 Taking of kicks from the penalty mark in accordance with the Laws of the Game or Rules of Indoor Soccer whichever is applicable.
17.5 If required, tie-breaking kicks from the penalty mark will be conducted as follows:
17.5.1 Two (2) teams tied: at a time and place decided by the Alberta Soccer Representative.
17.5.2 Three (3) teams tied: Each team is designated $\mathrm{A}, \mathrm{B}$, or C as determined by a random draw by the Alberta Soccer Representative.
17.5.2.1 Three (3) mini-games will be played, $A$ vs $B, B$ vs $C$, and $C$ vs $A$.
17.5.2.2 Each mini-game will consist of five (5) penalty kicks at a time and place determined by the Alberta Soccer Representative.
17.5.2.3 All five (5) penalty kicks must be taken.
17.5.2.4 Three (3) points will be awarded for a win and one (1) point for a tie.
17.5.2.5 The standings after these three (3) mini-games will be determined per the criteria above.
17.5.3 Four (4) teams tied: Each team is designated A, B, C, or D as determined by a random draw by the Alberta Soccer Representative.
17.5.3.1 Six (6) mini-games will be played, $A$ vs $B, C$ vs $D, A$ vs $C, B$ vs $D, D$ vs $A$, and $C$ vs $B$.
17.5.3.2 All five (5) penalty kicks must be taken.
17.5.3.3 Three (3) points will be awarded for a win and one (1) point for a tie.
17.5.3.4 The standings after these six (6) mini-games will be determined per the criteria above.
17.6 When teams have played an uneven number of group games the seeding procedure will be conducted as
follows:
17.6.1 Total points divided by the number of games played.
17.6.2 Total goals scored divided by the number of games played.
17.6.3 Plus/Minus divided by the total number of games played.
17.6.4 Kicks from the Penalty Mark.

## 18. GAME ABANDONMENT AND SUSPENSION

18.1 All games involving a team that does not fulfill all its playing obligations within the round-robin portion of the championship will be recorded as a 3-0 win for the opposing team.
18.2 If at the time of kick-off, a team does not have enough players to begin the game, the referee may delay for a maximum of ten (10) minutes. At the end of that time, if the team is still unable to field the minimum number of players, they will lose the game by a score of 3-0.
18.3 Where a game must be stopped due to any cause beyond the control of the participating teams, games will be restarted wherever possible.
18.3.1 When a game cannot be restarted and more than seventy percent (70\%) of the game has been played, the result at the time of abandonment will be recorded as the final score.
18.3.2 If a game is abandoned and the score is tied but the competition requires a winner, the winner shall be determined by penalty kicks. If at the discretion of the Alberta Soccer Representative, a penalty shootout cannot be conducted, a winner shall be determined by the flip of a coin.
18.3.3 When a game cannot be restarted and less than seventy percent (70\%) of the game has been played, the following shall occur:
18.3.3.1 the Alberta Soccer Representative will attempt to reschedule the game. Only the remaining time shall be played, and the score at the time of abandonment shall carry forward.
18.3.3.2 If, at the discretion of the Alberta Soccer Representative, the game cannot be rescheduled, a winner will be determined using kicks from the penalty mark.
18.3.3.3 If, at the discretion of the Alberta Soccer Representative, kicks from the penalty mark cannot be scheduled, a winner will be determined using a coin toss.
18.3.4 When a game cannot be played beyond the control of the Alberta Soccer Association, the result will be determined by using kicks from the penalty mark.
18.3.4.1 If, at the discretion of the Alberta Soccer Representative, kicks from the penalty mark cannot be scheduled, a winner will be determined using a coin toss.

## 19. DISCIPLINE

19.1 The Competitions Discipline Committee shall have three (3) members
19.1.1 One of the members shall act as a Chairman.
19.2 If, it is determined a conflict of interest or bias exists, the panel can be reduced to two (2) members if agreed to in writing by the accused.
19.3 Any specific matter related to a tournament may only be acted on by the established Competition Discipline Committee for the duration of each tournament.
19.3.1 Any decision made by the Competition Discipline Committee will be final.
19.3.2 Any concerns must be brought by the team official before the Competition Discipline Committee for a decision.
19.4 Misconduct by players or team officials reported by the referee will be dealt with by the Competition Discipline Committee prior to the next game.
19.4.1 Any misconduct in a team's final game in any competition may be delegated to the Alberta Soccer Discipline Committee or District which the player or team official represents.
19.5 If a hearing is requested, or if the Alberta Soccer Representative at their discretion so decides, the Competition Discipline Committee will conduct a hearing to deal with misconduct in accordance with the Alberta Soccer Discipline and Complaints Regulations and Appeals Policy
19.5.1 Notice periods will be waived, and Alberta Soccer mandatory suspensions will be applied. The District of the player or team official involved will be informed of the decision.
19.5.2 Failure to attend after notification by the Competition Discipline Committee may result in immediate suspension without appeal.
19.5.3 The Competition Discipline Committee will hold a hearing for behavior off the field for any player or team official alleged by the Alberta Soccer Representative to have brought the game into disrepute. The Committee may take any disciplinary action it sees fit including suspension from all soccer activity.
19.6 Three (3) yellow cards in a Provincial Championship will automatically generate a one (1) game suspension.
19.7 All Red cards in a Provincial Championships are subject to review by the Alberta Soccer Representative. If the situation warrants, the Alberta Soccer Representative may call a hearing to suspend the offending player for additional games above the following minimums:
19.7.1 Violent Conduct - two (2) games;
19.7.2 Offensive, Insulting, Abusive, Language and/or gestures - minimum of two (2) games suspension \& hearing at the request of the Alberta Soccer Competitions Representative
19.7.3 All other red cards - one (1) game
19.8 Any team official who receives an accumulation of two yellow cards will serve a one (1) game suspension, during which they will not be allowed on the bench.
19.9 Any team official who receives a red card from the referee will serve a minimum two (2) game suspension, during which they will not be allowed on the bench. If the situation warrants, based on the referee's report or other relevant evidence, the Alberta Soccer Representative may call a hearing to determine if additional sanctions are appropriate.
19.10 All suspensions must be served at the next Alberta Soccer sanctioned match the suspended individual would otherwise participate in.
19.11 Any individual serving a suspension may not participate in any other match until their suspension is served with the team where the suspension originated.
19.12 Any Youth player serving a suspension will be required to sit separately from the team and may not be dressed in a team kit. It is the responsibility of the team official to supervise any players serving a suspension and if requested by the officials or the Alberta Soccer representative, a team official will be required to sit with the suspended player.
19.13 Protests may be lodged with the Alberta Soccer Representative only on alleged deviation from these published rules. Protests must be in writing, clearly outline the complaint, and must be lodged within sixty (60) minutes of the game's end. All protests must be accompanied by a non-refundable protest fee of $\$ 250$. No protests will be heard which are based on a game official's interpretation of the Laws of the Game or Rules of Indoor Soccer.
19.13.1 The Alberta Soccer Representative will deal with all valid protests as outlined in the Alberta Soccer Discipline and Complaints Regulations and Appeals Policy.
19.14 In the case that an Alberta Soccer Representative at a Provincial Championship discovers, after team check-in, that a team has inserted an ineligible player, the Alberta Soccer Representative/Discipline Committee will declare that team's participation illegal and all matches will be defaulted.
19.14.1 Individuals who have been listed on a game sheet will be deemed to have participated in that game.
19.15 When a referee is required to submit a written misconduct report on a game incident it must be submitted on an ASA Misconduct Report form within one (1) hour after the end of the final officiating responsibility for that game. This period may be extended up to four (4) hours if the referee is on another assignment.
19.16 Any misconduct or infractions not covered by this rule book must follow the guidelines from the ASA Discipline and Complaints Regulations policy

## 20. FINES

20.1 All withdrawals of a team from a Provincial Championship must be submitted in writing by the District Association to the Alberta Soccer office. An administrative fine based on the number of days out from the championship will be assessed.
20.1.1 45+ days prior - $\$ 300$
20.1.2 Thirty-one (31) to forty-five (44) days prior - $\$ 550$
20.1.3 Thirty (30) to fifteen (15) days prior - $\$ 1,200$
20.1.4 Fourteen (14) days or less prior - $\$ 2700$.
20.1.5 Seven (7) days or less - $\$ 3000$
20.2 If a District can provide a replacement team, in accordance with Player and Team eligibility, fines may be reduced at the discretion of the Manager of Competitions.
20.3 For Outdoor all teams are expected to attend their scheduled games with a minimum of seven (7) players and are expected to compete in every game until completion. Any team failing to do so will be assessed a forfeiture fine of up to $\$ 2,500$, per game.
20.4 For Indoor, all teams are expected to attend their scheduled games with a minimum of four (4) players and are expected to compete in every game until completion. Any team failing to do so will be assessed a forfeiture fine of up to $\$ 2,500$, per game.
20.5 Any team found to have played an ineligible player will be assessed a fine of up to $\$ 2,500$.
20.6 All teams receiving a medal are expected to attend medal ceremonies. Any medal-winning team that does not attend medal ceremonies without receiving prior permission from the Provincial Representative will be assessed a fine of up to $\$ 500$.
20.7 Notice of any fines administered by the Manager of Competitions will be sent to the District that the team was representing. The home District assumes ultimate financial responsibility for the payment of any fines.
20.7.1 Fines are not appealable.

## 21. AWARDS

21.1 The winners of the Youth Provincial Championships will be awarded keeper trophies that they are not required to return to Alberta Soccer.

## 22. BLOOD-BORNE PATHOGENS

22.1 If bleeding occurs where other participants may be exposed to blood, the individual's participation must be interrupted until the bleeding has stopped the wound must be securely covered.
22.2 All clothing soiled with blood must be replaced prior to the athlete resuming competition.
22.3 If a player must replace a blood-stained jersey with one of a different number, the player may only enter after the referee has been advised of the change.

## 23. INJURY POLICY

23.1. A player, who receives medical attention from an Emergency Medical Technician or Doctor during the competition is deemed an ineligible player until the player has provided to the Alberta Soccer Representative a duly completed Return to Play Form or a doctor's letter allowing the player to resume participation.
