- h. Lakeland AGM Nominations Committee.
  - i. Looking at having a nominations committee going forward, is in the bylaws.
  - ii. President and 2<sup>nd</sup> VP are up for nomination
  - iii. Nominations may need to be made by one of the districts for you to be voted on for the position.
  - iv. Could be a board meeting between the presidents and executives to discuss this.
- i. Fees to be proposed at AGM:
  - i. Alberta Soccer fees increase: 2025 \$2 increase; 2026 \$1 increase; 2027 \$1 increase.
    - Proposing no increase at the district level next year, \$4 increase the following year.
    - Operational meeting will have the proposal written out.
    - To be voted on it at the AGM
  - ii. Lakeland FC Admin fee \$12 per player.
    - Executive director had a lot more to do with the additional teams and compensation should be provided.
  - iii. Non-Ramp user fee \$1.25 per player/staff. (exception for clubs with 100 or less registrations)
    - Two AGMs that it has been discussed, this year we will be proposing it.
    - LLB is already looking into getting RAMP for their registrations.
- j. Bylaws Committee.
- i. Bylaws need to be revamped.
- ii. May need to move board structure into something more normalized.
- iii. Would like to have them worked on this winter.
- k. Learning Facilitator Course / C-Diploma Course.
  - i. More discussion at the next weekend.
  - ii. C-Diploma course went up from \$500 to \$2000
  - iii. Do not want to set a precedent paying for C-Diploma courses, however if they are continuing to complete a learning facilitator course then some reimbursement may be warranted.
  - iv. Proposal to be provided by next meeting
- I. Lakeland FC Program growth.
  - i. 2 teams for the past two years, 5 teams this past summer
  - ii. Gold, Bronze, two 4ths and a 5<sup>th</sup> place
  - iii. Could have 6 teams next year
  - iv. This could at some point go into its own separate club, an FC director could be introduced to help deal with the extra work associated with these teams
  - v. More time may be needed to ensure that teams are more cohesive by the time provincials come around.
