Regulation Five (A)

All OWHA teams must have registered, at least one coach with a minimum certification of National Coaching Certification "Coach Level" or Hockey Canada Initiation Program for Tykes, Novice & Atom. All OWHA teams must have at least one female staff registered.

Regulation Five (B)

All teams must have a registered trainer with a minimum of HTCP Level 1 certification present at all events, including games, practices and dry-land training.

Speak Out!/Respect in Sport - All bench, on ice and dressing room staff, must attend a Speak Out/Respect in Sport Clinic in order to work with an OWHA team.

Criminal Record Check – All coaches, Assistant Coaches and Trainers are required to supply a current Criminal Record Check (must be updated every year). These must be submitted to the league executive prior to any member (coach, assistant coach, trainer) being on ice/off ice with players. No exceptions.

** Please note that coaching assignments are at the discretion of the Coaches Committee. Applications for divisions will be reviewed and selected based on criteria established by the Coaches Committee. No application is guaranteed to be granted as submitted and changes to assignments may occur.
