

LANGENBURG REMAX ARENA RE-OPEN COVID-19 PLAN



All ice times must be booked through the Rec Office.

All COVID-19 Protocols are subject to change on short notice.

General

- Wash your hands with soap and water before and after your activity.
- Avoid touching your eyes, nose, mouth and face.
- Cover coughs and sneezes in a tissue or your elbow.
- Use hand sanitizer whenever possible.
- Please **STAY HOME** if:
 - You or any of your household members are experiencing any symptoms or feeling unwell.
 - You have travelled outside of Canada in the past 14 days.
 - You have been in close contact with someone who has tested positive for COVID-19 or are waiting for test results for COVID-19.
- Maintain a social distance of 6 feet from others where ever possible. (Follow the markers through out the facility).
- Be mindful of common surfaces and limit touch points.
- Do not gather or loiter in the lobby, entrance, dressing rooms, bathrooms or any public area. Please do not enter any barricaded areas.
- Ensure all garbage and recycling is placed in appropriate bins.
- ***Before user groups are allowed to rent the ice a COVID-19 response plan for how they will return to play must be submitted to the Recreation Office and approved by the Town of Langenburg.***

Masks and Face Coverings

- Saskatchewan Hockey Association has implemented a face covering policy that the skating arena will follow for all user groups and rentals. This included players, coaches, bench staff, on-ice officials, off-ice officials and parents/spectators. **Non-medical mask which covers the mouth and nose - the material can be cloth or other material and must be worn when entering the arena and continue to be worn until player/coach/official has placed their helmet on to head to the ice surface. Face coverings should be promptly placed back on once in the dressing room and helmet is removed. Spectators, off-ice officials, and bench coaches will be required to wear a face covering at all times in the facility.**
- Where physical distancing cannot be maintained during on-ice sessions coaches/instructors are advised to wear a mask. This would be directed towards early age skaters/hockey players.

Keeping our patrons, users and staff safe during COVID-19

- We have established a regular and dedicated cleaning routine with established COVID-19 sanitizers. Our choice of sanitizers will include:
 - Hand Sanitizer (Benzalkonium chloride solution).
 - Clorox® Total 360® Disinfectant Cleaner with sprayer
 - Bioesque Botanical Disinfectant Solution – If CLOROX becomes backordered
- Ensuring our facilities align with the provincial guidelines.
- Providing access to hand sanitizer.
- Having staff maintain physical distancing.

Langenburg Remax Specific Measures

- Vending machines are not available- please make sure to bring a labeled water bottle – that is filled prior to arriving at the facility.

- Faucets in change rooms and washrooms should only be used for washing hands.
- **For practices:** skaters are aloud one parent to watch, they must sit in Section 1 (refer to the covid seating plan map at the end of this document)
- Areas will be barricaded off to limit the amount of cleaning and disinfecting required.
- Changerooms are open with physical distancing measures in place.
- Shower facilities are available however limited to 2 users at any one time and we strongly encourage skaters go home to shower.
- User groups are expected to maintain cohort groups on and off the ice.
- Facility capacity shall be determined in the following priority:
 1. Saskatchewan Health Authority Guidelines
 2. Town of Langenburg Guidelines
 3. Provincial Sport Governing Body Guidelines
- Currently no more than 30 participants are allowed on the ice surface at one time.
- Cohorts or mini leagues are made up of 50 people or 4 teams. Therefore we will only sanitize after each cohort has used the facility.
- A maximum of 10 participants are allowed per dressing room. Sit according to the markings on the benches.
- At this time the kitchen will remain closed.

Building Entry

- Entrance will be through the marked doors on the front entrance.
- Exits for practices shall be through the front entrance but a different door will be marked for the exit. (Doors 1 and 3 will be used).
- **Exits for games will be as follows:**
 - West side bleachers will exit the facility using the lobby doors to minimize crowding in the foyer
 - Exit arrows will be taped to define exiting from west side
 - We will have scheduled exiting times, this will be announced. Please remain seated until your section is called out to leave. The order will be:
 - Section 1 & 4

▪ Section 2 & 3

- Spectators will be asked to stay seated throughout the entire game – this includes during intermissions. If you must exit your seat it is for washroom use or to step outside. However we encourage that you do not exit the facility until the end of the game
- Participants are encouraged to arrive at the arena in partial equipment because of the shortened time available to get ready. (15 minutes practice, 30 minutes games).
- Follow all on site signage.
- Arrive no earlier than 15 minutes before your scheduled ice time and depart within 15 minutes after your scheduled ice time for practices and 30 minutes for games.

User Group Responsibilities

- Everyone must adhere to all guidelines current to the date of rental as outlined in the Re-open Saskatchewan plan and the Saskatchewan Public Health Order. <https://www.saskatchewan.ca/government/health-care-administration-and-provider-resources/treatment-procedures-and-guidelines/emerging-public-health-issues/2019-novel-coronavirus/re-open-saskatchewan-plan>
- Please be aware of any specific National or Provincial Sport Governing Body guidelines as it relates to COVID-19.
- Everyone must adhere to any special guidelines as outlined by the Town of Langenburg.
- Coaches or Program Leaders shall be deemed “sanitization champions” and shall be responsible for ensuring guidelines are followed as well as your group will be responsible for sanitizing the dressing rooms.
- Collect participant contact information to support tracing if necessary.
- All users must bring their own pre-filled water bottle.
- Sanitize and disinfect any shared equipment used.

Participants and Spectators

- Understand universal precautions to avoid the spread of COVID-19.
- Each user group will be required to sign a COVID-19 Guidelines and Waiver at least 7 days prior to their first on ice activity.

- At this time spectators will only be aloud on outside bleachers, the lobby and upstairs area will remain closed. This will have an ongoing evaluation as guidelines change through the season.

Volunteer Game Announcers Duties:

- Only 1 person is aloud in the soundroom
- Announcers are responsible for disinfecting the mic and scoreboard after each game.
- The announcer will be responsible for announcing the following throughout the game:
 - Please stay seated in your socially distanced cordon at all times
 - Please do not loiter in the lobby
 - You may get up to use the washroom or to step outside
 - Children must remain seated with family members, they cannot play indoors
 - At the end of the game remain seated until we allow your section to leave the facility
 - Section 1 & 4 will go first
 - Section 2 &3 will go second
 - All west side bleachers (sections 3 &4) please use the middle doors located in the lobby, follow the exit arrows
 - Masks are mandatory at all times for spectators

Langenburg Remax Arena Responsibilities

- Ensure we are aligned with the Government of Saskatchewan’s Guidelines and regulations.
- Provide access to hand sanitizer and hand washing stations.
- Clean and disinfect daily. Spectator stands will be disinfected between mini-league groups or practice “cohorts” not every booking.

Record of Participants



- User group shall:
 - Register each participant/parent/guardian attending a session. Records shall be kept for 30 days and will be made available to the Town of Langenburg at their request. How you record this is up to you. Our suggestion is to create a Google Form.
