**Team Formation** 

All evaluations are set forth by the Canadian Lacrosse Association (CLA), Alberta Lacrosse Association (ALA) and the Greater Edmonton Lacrosse Council (GELC) as these are the regulatory guidelines and rules we MUST follow for the sport.

## **Team Formation**

## **U7 Athletes:**

- Minimal evaluations required.
- Athletes are setup to develop muscle memory for the sport and to gain valuable "age" specific skill development to learn the game of lacrosse.
- Team selection is based on parody with full consideration of family and friends to participate together as a core group (team numbers have to be considered during this process).
- Teams share the floor during practices and coach can work together if wish. This age is to be separated for "Jamboree's" and team specific events.

## **U9 Athletes:**

- Minimal evaluations required.
- Kids are still in the full development process of sport.
- Athletes are setup to develop muscle memory for the sport and to gain valuable "age" specific skill development to learn the game of lacrosse.
- Team selection is based on parody with some consideration of players wanting to play with friends.
- Teams may practice together but will be fully separated for league games and tournaments.
- No "A", "B", or "C" level lacrosse.

## U11 Athletes:

- Limited evaluation process required as skill level for athletes starts to separate at this
  age group.
- Athletes are setup to develop muscle memory for the sport and to gain valuable "age" specific skill development to learn the game of lacrosse.
- Team selection is based on parody with limited consideration of players wanting to play with family and friends (based on skill and experience of athletes involved).
- Teams will practice individually with separate floor times.
- No "A", "B", or "C" level lacrosse.
- Athletes need to start understanding that they may or may not be playing with their friends for other sports or schools.

### U13 Athletes:

- Full evaluation process for this age group to base team selection on parody programs and to separate "A" level athletes from "B" level athletes.
- "A" Level programs are available at this age group.
- Parents will be required to register their children for "A" evaluations if they intend to do so.

- Fees associated with registering athletes for "A" level lacrosse are necessary to pay for "third-party" evaluators, so the process is transparent and non-biased.
- After all, "A" level evaluation have taken place, the rest of the registered athletes will be separated based on parody.
- During team formation of parody teams, skill level of different athletes will be separated before anything else.
- After the skill level has been separated for parody, then the athletes will be separated based on "left-handed" and "right-handed" abilities as this is the process in order to balance the positions of the athletes for development reasons.
- Coaching Staff play a role in team placement.
- Please note that there is many criteria to select athletes from based on a parody program. Given the number of registrants, typically the teams are already selected after talent and ability are considered heavily.
- Very limited consideration for friends and family to participate together.

## U15 Athletes:

- Full evaluation process for this age group to base team selection on parody programs and to separate "A" level athletes from "B" level athletes.
- "A" Level programs are available at this age group.
- Parents will be required to register their children for "A" evaluations if they intend to do so.
- Fees associated with registering athletes for "A" level lacrosse are necessary to pay for "third-party" evaluators, so the process is transparent and non-biased.
- After all, "A" level evaluation have taken place, the rest of the registered athletes will be separated based on parody.
- During team formation of parody teams, skill level of different athletes will be separated before anything else.
- After the skill level has been separated for parody, then the athletes will be separated based on "left-handed" and "right-handed" abilities as this is the process in order to balance the positions of the athletes for development reasons.
- Coaching Staff play a role in team placement.
- Please note that there is many criteria to select athletes from based on a parody program. Given the number of registrants, typically the teams are already selected after talent and ability are considered heavily.
- NO Consideration friends to play together.
- Consideration will be looked at for family members with the same last name

## **U17 Athletes:**

- Full evaluation process for this age group to base team selection on parody programs and to separate "A" level athletes from "B" level athletes.
- "A" Level programs are available at this age group.
- Parents will be required to register their children for "A" evaluations if they intend to do so.
- Fees associated with registering athletes for "A" level lacrosse are necessary to pay for "third-party" evaluators, so the process is transparent and non-biased.

- After Coaching Staff play a role in team placement.
- all "A" level evaluation have taken place, the rest of the registered athletes will be separated based on parody.
- During team formation of parody teams, skill level of different athletes will be separated before anything else.
- After the skill level has been separated for parody, then the athletes will be separated based on "left-handed" and "right-handed" abilities as this is the process in order to balance the positions of the athletes for development reasons.
- Please note that there is many criteria to select athletes from based on a parody program. Given the number of registrants, typically the teams are already selected after talent and ability are considered heavily.
- NO Consideration friends to play together.
- Consideration will be looked at for family members with the same last name.
- All second year "A" level athletes are eligible to be drafted for the "Junior" programs provided by the RMLL.

As a new guideline starting for the 2024 Lacrosse season, all families are required to complete the "Respect in Sport" program. As you all have been informed with this program, a mandatory 24-hour period is required before you express your concerns. Only concerns put in writing will be addressed. If this protocol is not followed, all concerns will be voided.

If you have any concerns or comments, we ask that you refrain from expressing them on social media and please direct them to appropriate Board member associated with their roles and responsibilities. The GELC has changed their social media code of conduct for the 2024 season and fines can be implemented if these guidelines are NOT met.
