- a) President's Report Mike Baker

  - Looking at partnering with Beaumont for U10 step 3 and U12, we would keep the association separate however combine these levels to allow for better player development.
    - There will be a suggestion made to alternate years so that everyone should get a year wearing their "home" jersey's ie: 2024/2025 U10 would be Beaumont and U12 would be Leduc and then 2024/2025 that would switch
    - All players would need to be evaluated at the same time and this way we would we split the cost of ice and evaluators
    - U14 & U16 will not be circled into this partnership this year but maybe in following years
    - O Concerns are obtaining the buy in from the parents
    - The board will need full by in
    - o If this moves forward it will be discussed at the AGM
    - We will need blending coaching staff, with Leduc currently having stronger coaching staff
       and Beaumont having stronger junior coaching staff
    - We would like to see players moving up, all the pools are very diluted
    - Kevin had a meeting with the LRC regarding ice the issue the LRC has is the 10/10 rule 90% must be from either the City of Leduc or the County of Leduc (this does not include cities/towns in the County) and only % can be import this then could/can affect out ice costs
    - o The LRC is concerned this is not a partnership but rather a merge which its not
    - LRC is concerned that they do not want our competitive teams taking all the ice time and leaving little left for our local opportunities
    - Moving kids around shouldn't affect costs however maybe the more competitive teams will have extra costs associated with play
    - Everyone with a show of hands wanted to move forward
    - A Sub-Committee was formed Kevin Paul, Mike Baker, Amy Shipley, Crystal Kardelis and Chelsea Cameron – they will present a plan at the next board meeting
  - Policies and by-laws to be pushed as we need to ensure we are aligned with Beaumont.
