Call to Order -6:32p

**Approval of minutes** from previous meeting- adjust the \$1100 Regionals in U12 (Thanks Arne), Trish motions, Haley seconds - all in favor

**CRL / RAB update** - CRL is struggling - they may fold back into RC, lack of organization. We will see what happens. It was advantageous for Associations like ours to have CRL.

**Bridge Battle Spring Update** - 24 teams, Trish, Haley, Gord, etc will all be around. Last game ends 1:45 on Sunday.

**Springette Update** - lots of registrations for Sunday. Went through groupings with Rob, Gord, Kurt - roll a mini springette on mondays (combine other 2 groups). Hire some Junior Coaches to run for Step 1 or 2?

**Rattler Challenge Update** - a few less sessions, nice way to wrap up. Try to fit in a final skate with team. Then 2 day rattler challenge, try to engage U16/U19 in leadership roles. Need volunteers - Haley will help

**Arena Boards** - foam dividers - they are quite expensive. Minor hockey has a set at Enmax that they would sell the LRA for \$2000 (new is \$5000-\$6000). Should we buy? Need Permission to store them at Henderson. Gord/Cara are requesting a meeting with the City will add to agenda. The half ice boards were a big investment - risk is they won't get used. Motion is contingent on storage -ROb makes a motion to purchase from Mhockey, HAley seconds. All in favor.

**Rings** - Recently a ref said that made in China (canadian Tire) could not be used, made in Taiwan is okay. Shalane emailed Lauren from RAB to confirm. Ringjet has corrected the issue - all rings accepted.

**Hotel agreement discussion** - \$5000/yr from Best Western to host BBS as a Stay and play. This is our final year, is it worth renegotiating? Cara/Gord will talk to Bruce about future opportunities.

**CTR / Promotions –** update - Ready to go with 3 registered. cometryringette.ca - pick Lethbridge as destination. Phil ready to lead (and with goalies) Use the 16s.

**Highway Clean Up** -. We inherited the U19 section and the section of 43rd. First weekend of May - Raj will send it in. We have 30Kms. The idea is to use as many people as possible from Coaldale to Lethbridge. Ppl who have not done their volunteer shifts are targeted first, then to the teams for \$100/player. Need a Highway Volunteer Coordinator Role - so people know exactly where they are going.
