Minutes from last meeting – need approval after this meeting

- 1. Registration Fees/dates; 40 registered to date (3 new kids + 5 Active Start), Early bird ends July 14, Registration open until Sept 14.
- 2. Budget for all portfolios Purpose is to get a handle on where we are at and rough of idea is what's needed and approve it at this amount so that she can spend within that budget. If there is an overage, we would bring back to the board to approve later on.
  - a. Promotions future, would be good to include the cost to print and % that the City charges back.
  - b. Coaching kept similar to last year, Reached out to Loralee said that coaching clinic goes to Med Hat may increase expenses slightly
  - c. Player Dev increased rate for conditioning camp coaches (\$25/hr), Power Skating remained the same, Goalie Coach (15 clinics @2 Coaches @\$30/hr), Goalie Training (4 clinics with sport psychologist, team conditioning proposed (Proof of receipt)
  - d. Ice This is based off the total requested for the upcoming season (do we need to take Power Skating out of the total), Only 2 rinks available for provincials. Is it worth trying to get regular game ice in Vulcan/Stavely? Should have practice ice in mid July this will allow us to book in outside locations if required. Picture butte, Raymond, Coaldale for Power Skating Ice, offer baseline programming but if coaches want to search out some other options they are welcome.
  - e. Registration based on last year's actuals No increase to registration fees. Expense is \$100 head coach discount (calculated off 15 coaches). Added in Springette and Rattle off the Rust Cara and Rob will determine where the coaching expense will go for the extras (Mini Springette).
  - f. Tournaments Expenses staying the same, Daelynn will look at increasing fees (By \$50 or \$75) in lieu of partnering with Lethbridge Lodging Association as it was a massive hassle. Daelynn will put together past rate and propose new dates for Aug Meeting (along with Ice avail). Cara/Daelynn will put together proposed scenarios for Aug
  - g. Referees anyone over the age of 18 require a criminal record check (increase in fees), RAMP assignor was great, will keep (Take out of IT). Find out about fees for mic'd up (pilot program with CRL) and what the hopeful outcomes would be.

- h. Promotions add \$600 for new Ice logos Shalane/Trish need to reach out to city about when they need the logo. Rattler Challenge income reflected in Promotions budget
- i. Equipment ordered 12 Rattler Bags, looking into Garment bags (600),
  - i. Sponsors for Jerseys? Can you patch over LRA logo with Rattlers? Yellow Jerseys? Smaller Goalie Jerseys? Jerseys are \$176 each. Shalane will look into patch that covers LRA logo, reversible jerseys?
- j. IT RAMP costs pulled from website, Fees,
- k. Treasurer Look into an Etransfer specific account (not the main account)
- I. Volunteer allocate for 1-2 buyouts, Misc Expenses

- 3. Rattle off the Rust/Rust Buster Asked for extra ice not able to get more. 3 spots x 18 places (\$50/player), 4 nights, U12/U14 and U16/U19 together. Rolled out registration June 26 on Google Form Teams out by Aug 1. Had to be registered in upcoming season and registered in what they are playing coming. Aug 25-28, evenings at CFC. Cara/Rob will set up and make a process for future player development, add a "I'd like to be a coordinator this is my volunteer shift". Apply for sanction/special ice permit Kayelene will take care of.
- 4. Scholarship info on website \$1500 added to the Promotions Budget, want to vote on it before the banner raising.. put info on the website closing Aug 15, 2025.
