- 2. Approval of Oct minutes -Rachel Motions, Cristy seconds, approved
- 3. Proposals Submitted
 - a. Non Parent Coaches Financial Support

Background - historically teams fund this - as the number of non parent coaches increase, what is the most reasonable amount and process to facilitate this - is there a proposal for this season - then necessary for the committee to propose policy? Haley Gord - would like to support non parent coaches and women coming back to support the sport of ringette, are there grant or sponsor opportunities to support this financially. We have to be consistent, if any team has a non parent coach - the support should be the same. If the head coach is the only female, is that different than an assistant coach? Kelly - would like to see a cost share model between the association and the team. DPD - not in support of LRA bearing full cost to support these coaches. Strike a committee - Haley, Daelyn, Kendra, Kelly - Meet before Dec meeting and come back with a proposal and a budget template.

b. Referee Swag - Kendra

Background: Recognition and appreciation - 22 t shirts at approx \$30/shirt, or hoodies at \$44/ref + \$20 Shipping (preference is hoodies). GEt RAB logo and OFFICIAL - total is \$1000 for hoodies, or \$567.00 for Tshirts, all 21 officials. Haley makes the motion for the LRA to pay for hoodies for all 21 officials, Daelyn seconds, all in favor.

c. Digital feedback mechanism on website with certain categories gets directed to Pres/VP to give to appropriate portfolio-

Background: Make providing feedback as easy as possible for members - is it possible to set up a quick link on the website? Max says "depends on the cost" and the RAMP plug in capacity.

Gord - from a simple phish it's possible to get the information about board members and emails and use. Can we fill in a form that is under each portfolio for submission vs. email and title.

ACTION:Max - take off all coach information from the LRA website, Kayelene - is there a RAMP Functionality that can be unchecked so that personal information is not listed on the LRA website.

ACTION: Gord/Max/Tracy - draft a form template - and post link to website - provide form template to the board prior to Dec meeting

Email Management - unique emails, or just a general info email that is manages all inquiries, Prior to the AGM and next group of directors - have a plan for emails for board members

i. Members pre read the proposals sent out by Rachel last week - please be prepared to choose between the 3 firms - we also need a new book keeper as the one we have had for 5 years is too busy now.

Compilation Engagement likely covers what we need - and we can add criteria (notes, etc), After meeting adjustment - given that MNP and Best and Roest currently sponsor our association it was felt that asking them to additionally deliver a service to our association was not a preferred approach - asking them to factor in bookkeeping and then email vote to follow.

- e. Concussion Protocol Tracy
 - Was brought up in Oct is there a proposal for how to support LRA families with return to play or an awareness campaign -

RAB guidelines are setting the precedent- confirmed diagnosis as concussion. Every coach is required to take "making headway". Let's do an education piece that we can showcase to the membership.

 - f. Feedback on new jersey vendor we need to order new jerseys this season so if those aren't the ones who is the vendor?

Players bench jerseys (Horns) - this is the right pantone - what is the cost? They can create namebars

Shalane - Bowview - families pay for namebars, and hire a company to put name bars on and off.

Add what registration covers on operational expense vs. capital expense. Current operational costs exceed revenues, residual gaming funds are contributing to "Surplus" - ongoing plan to spend this down (Jerseys for whole association, creation of legal mitigation fund, and additional suggestions that will take place this fiscal year.

Motion - Shalane motions to have an inventory of rattler bags and garment bags, hats, up to expenditure of \$5000, sold on a cost recovery basis. Haley seconds, everyone in favor.
