Lethbridge Soccer Association - Playing-Up Policy

Introduction:

The Lethbridge Soccer Association (LSA) and Lethbridge Football Club (LFC) is committed to fostering the growth and development of youth soccer players while providing a safe and enjoyable environment for all participants. The "Playing-Up Policy" is established to address cases where players may exhibit exceptional skills and maturity, allowing them to compete in higher age groups. This policy aims to strike a balance between individual player development and maintaining the integrity of age-appropriate competition.

Eligibility and Factors for Consideration:

- a. Age Group Difference: Players seeking to play up must be at least one year younger than the age group they intend to join.
- b. Skill Assessment: The decision to allow a player to play up will be based on a comprehensive assessment of the player's technical skills, tactical understanding, physical attributes, and emotional maturity.

Criteria for Playing Up:

- a. Skill Level: Players must display a skill level significantly above their current age group's standards to contribute positively to the desired age group.
- b. Emotional and Social Maturity: Players should demonstrate emotional resilience, strong communication skills, and the ability to integrate well with older teammates.
- c. Physical Readiness: Players must exhibit physical attributes appropriate for competing safely and effectively in the desired age group.
- d. Parent/Guardian Consent: Consent from the player's parent or guardian is required for consideration to play up.

Evaluation Process:

- a. LFC Staff Assessment: The Technical Director, LFC Director or LFC Developmental Lead Coaches will conduct a thorough evaluation, considering the factors outlined in the policy.
- b. LFC Coaches Recommendation: The players current LFC coach can request the LFC Staff to carry out an assessment on the player to see whether they fit the assessment guidelines.

Decision-Making Process:

- a. Collective Decision: The final decision to allow a player to play up will be made by the Technical Director, the team coaches will be kept updated on the situation throughout.
- b. Player's Best Interests: The primary consideration will be the player's development and overall well-being.

Monitoring and Review:

- a. Regular Assessment: Players playing up will undergo periodic assessments to ensure that their development remains on track and that they are adapting well to the new environment.
- b. Seasonly Review: The player's situation will be reviewed annually to determine if playing up continues to be beneficial or requires adjustments.

Communication:

- a. Transparent Communication: All decisions regarding playing up requests will be communicated transparently to the player, parents/guardians, coaches, and relevant team members.
- b. Feedback Mechanism: Parents and coaches are encouraged to maintain open communication to discuss the player's progress and any concerns that may arise.

In rare cases where a player exhibits extraordinary skills and maturity beyond the stated criteria, exceptions to the policy may be considered.
