- O Colin researched the process and the learned that there are at least (3) locations in Lloydminster that offer the baseline and follow-up screening
- O Cost is averaged at \$50/year for the advanced assessment
  - Board agreed this is not a cost that we can afford for each player in the association, neither can we determine that some leagues and levels are more susceptible than others
  - As an association, we will educate our parents on the extreme value in the process and understanding concussions through our website and social media (as we are able to manage moving forward)
