- **4. Review of Previous Meeting Minutes:** August 17, 2021. *Motion to Approve; Carried –* 13 For, 0 against, 0 Abstained
- 5. Business Arising from Previous Meeting:
 - a. U13 Female Tiering Update. Chad and Aaron updated the group on the results of the U13 parent survey. 42 out of 48 people responded. The survey results met the criteria of the motion. The U13 Tier 1 team was declined entry into the Rocky Mountain league but was approved to play in the U15 division in the ECFHL. There will be 15 skaters and 2 goalies on this roster. The U13 females will be moved into the outside evaluation process. Motion: Due to the survey results meeting the criteria of the August 17th motion, the U13 Female division will have 1 tiered team that will be evaluated by the outside evaluation process. No tryout fees will be charged. This team will play in the U15 Division in the ECFHL. Motion to approve; Carried 11 For, 0 against, 2 Abstained.
