New Business:

- Mission is asking to change to light grey with green and white
 - o Motion to change their primary colour to light grey with green and white
 - Jeff and Sandra approved
- Ridge Meadows changing the logo and design of the jersey
 - Motion to allow ridge to change their jersey
 - Jeff and Gord
- Pricing and registrations
 - o If getting released at the end of the season
 - Proposing from Sean to have everyone go to a 4 tier pricing with BCLA so every group has a consistent dates of the registration
 - o Tier 1 pricing from Dec 1-Dec 31
 - Tier 2 pricing from January 1- January 31
 - Tier 3 pricing from February 1-February 28
 - Tier 4 pricing after March 1 to May 15
 - Suggestion to change price to increase substantial
 - Feedback by increasing the fees at the later amount it can hurt the low income families
 - Until May 15th they can register in the system. After May 15th registrations can be accepted until June 20th with commission approval
 - Discussion was around the table about the registration process
 - Sean finds the four tiers works well
 - o Dates would also help with the BCLA promoting the registration of the league

- Question on Concussion protocol needs to be based on your baseline policy and there are different ways to do. CCMI is about \$80.
 - Mandatory for 2020.
 - If it is not covered by their extended health, there are other low income plan options
 - Need to be accessed after a concussion and if the base line clears them they can be back at work
 - Additional discussion on the process of the protocols
 - If it got passed at the CLA then that is what BCLA will use and unless someone changes the policy to set it as a specific
 - Need to use a reputable company
 - Needs to be consistent between all sports
- Looks like all of the island will be going with 3 on 3 at the tyke and are looking at doing
 place and push for all of the Novice age
 - o We should look at going with place and push for Novice
 - Different cultures don't play because of hitting
 - Possibly look at a gradual hitting process could be hard at referees
