### Currently Reads

In extreme circumstances where an association may not have a B or C team to call from either within the same divisions or the division below the team may ask permission from the (2) league commissioners for an A players from the division below to be called up prior to the game, both commissioners must discuss and be in agreement. If approved the team can on;y have 2 "A " players max. only applies to league play The league chair must be notified from the commissioner of the team who requested the A player whether approved or denied and with a rationale /

# **Proposed Amendment**

In the case of players up in a division, if an "A" player is going to play up to a "B" or "C" team, only a maximum of two (2) players per game playing up to a higher division is allowed. (with the exception of goalie)

#### Amended Motion:

where an association may not have a B or C team to call from either within the same divisions or the division below the team may ask an A players from the division below to be called up prior to the game, team can only have 2 "A" players max(with the exception of goalie). only applies to league play

Rationale: Removes extreme circumstances & the commissioner discussion and approval or denied process and Chair to be notified, to come into alignment of Minor directorate policy 4:07 Part 1 playing up. proper call up procedures still apply.

### Currently Reads

No player may play down in other than his own division of calibre. In exceptional circumstances, written application may be made to the LMMLC Chair to have a player play in other than his own category . The request must include that the Association and the player's parent or guardian understand that the player may not be eligible to participate in a Provincial tournament when playing down in a lower division .

### **Proposed Amendment**

- a. A player may play down one division than their appropriate age group when a player size and /or ability dictate necessary as determined by a coach and approved by an Association President. If approved by the local association, LMMLC must approve in writing and forward to their local Commission for Approval
- b. Players granted an opportunity to play down will have their players' statistics reviewed during the season of play (for penalties ,scoring etc ) . The MD will communicate the names of players playing down to the league Commissioners, who will need to keep statistics and report to the LMMLC and MD any anomalies seen during review of game sheets, or at a game. Upon review by the LMMLC and MD, a previously approved application to play down from Minor to Minor can be reversed at any time during the season of play. An over age player MAY be eligible for playdowns, playoffs, Zone /Commission Championships or for Provincial Championships play. The MD determination will include at least the following: penalties review, scoring, participation.

Rationale: to expand the correct wording to align with Minor Directorate policy 4:07 part ll - (a) & (b) playing down.

New policy – addition to D-1 residency

- 7. a. Any player that is found not following the residency rules outlined in the Minor Directorate policy will be deemed ineligible to play further for the current season and may be subject to a hearing with the commission to determine if further disciplinary action should be taken
  - b. Any association that is found not following the residency rules outlined in the Minor Directorate policy will be fined \$1000 for each player and may be deemed not in good standing with the league upon a vote of the commission members

Rationale: to have some enforcement at the league level for players and associations that are not following the residency rules. Players choosing to play in another association without obtaining proper permission are hurting all of the clubs growth, planning and development of the game, based on members discussions in September

For female U13, U15 and U17 only; 12 teams need to be declared before tiering can take place.

Declare as follows

1 team 1-tier 1 or 1-teir 2
2 team 1-tier 1 or 1-teir 2
3 team 1-tier 1 or 2-teir 2
2-tier 1 or 1-teir 2
4 team 2-tier 1 or 2-teir 2

Interlocking may happen and teams would be placed after tiering break.

# **Proposed Amendment**

For female U13, U15 and U17 only; 12 teams need to be declared before tiering can take place. A vote by the members at the declaration meeting will determine if there are enough teams to declare an A and B division. When declaring the following must be followed

#### Declare as follows

1 team 1-A or 1-B
2 team 1-A and 1-B
2 balanced B

3 team 1-A and 2-B (balanced)

2-A and 1-B

4 team 2-A and 2-B

Interlocking may happen and teams would be placed after tiering break. If an association declares two teams as one A and one B they will not need to rebalance should tiering not take place after the tiering break

Rationale: to align the divisions as A and B like we already have and to take away the arbitrary number of teams to have the two divisions bringing the policy in-line with what the membership asked for last year

Currently reads

Any team which is moved to a different level of league play will receive an accumulative number of points equal to the average of the balance of the teams playing at that level. Teams who move within the same caliber and division which has been split into 2 levels will keep their points and not receive accumulative. (for example if U15 B is split into Blue and Green and a team moves from Blue to Green they keep their points awarded when in blue.)

### Proposed Amendment

Any team which is moved to a different level of league play will receive an accumulative number of points equal to the average of the balance of the teams playing at that level. (in the case of interlocking play they will keep the number of points earned if staying within one of the two divisions that was involved in the interlocking) Teams who move within the same caliber and division which has been split into 2 levels will keep their points and not receive accumulative.

( for example if U15 B is split into Blue and Green and a team moves from Blue to Green they keep their points awarded when in blue.)

Rationale: when teams are moved up and down the balance of teams can sway the average points, with interlocking the team could have earned more points than if they received the average and have played teams in that division already leaving them at a disadvantage

## Currently reads

In U17, U13 and U11 where "C" leagues are formed, no Association may declare a "C" calibre team with more average years playing experience per player than two years for U11 and U13, three years for U15, four years for U17, times the number of registered players on that team. This rule does not apply to teams that are moved down to the "C" division by their Commission. (Example: U13 15 players on a team – total number of years of experience is 24 years –  $(15-3) \times 2 = 24$ ).

# Proposed change

In U17, U15, U13 and U11 where "C" leagues are formed, no Association may declare a "C" calibre team with more average years playing experience per player than outlined in the current minor directorate operating policy on declared "C" teams

Rationale: the minor directorate policy has all of the details that were not listed correctly above and best to refer to another policy than duplicate and have an error
