# **Female Report**

- provincials for females have been moved to Surrey with the same dates of July 12-15

#### Coaches -

- Clinics are being posted now book them now as their probably won't be any clinics after May
- looking for coaches reps for provincials
- Tyke rules option L and the notes using B for the fall back rule
  - We recommend using a regular hard ball for all games.
  - We will be using B for the fall back rule with the following exception Once the goalkeeper has passed the ball (not necessarily caught), all players are free to move within both zones.
  - After a goal, the play starts with goalie that was scored on. Fall back rule applies.
  - Place and push only, no cross checking allowed.
  - There are no timed line changes. Teams will change on the fly. Fair play policy always applies to ensure all players receive equal floor time.
  - PENALTIES:
  - If a penalty is called the offending player will leave the floor to the penalty box and serve the appropriate time for the infraction. Teams will play man down. Play starts with the ball given to the non-offending team's goalkeeper (3 pass rule applies).
  - 3 PASS RULE
  - Min 1 pass in the defensive zone, goalie pass will count
  - Min 2 passes in the offensive zone prior to being allowed to count a goal
  - should a goal be scored prior to the above then possession will be awarded to the nonoffending team
  - the reset of the pass rule will occur only once the other team has moved the ball down the floor and into the other team's offensive zone (inside restraining lines). If a player with the ball is legally checked prior to crossing into the offensive zone the 3 pass rule would not apply

- Clinics are up and running
- Emphasize in female bantam keep it as less physical as possible

## **New Business:**

Concussion baseline testing – pass over the Sean from Surrey to discuss this

- Surrey lacrosse has been doing this since 2016 as part of the operation policy
- Covered on most extended medical plans is testing
- They use complete concussion management and they work with players on management
- The base line is a self-compare test as they get the baseline testing

- Surrey paid a portion to start and has now changed it to parent pays and all players must complete the baseline test
- It is mandatory at pee wee and above, below it is optional
- It is transferable and is annual testing that covers them throughout the year
- The CCM reps are very helpful and a good resource
- In Ontario there is a new law coming into effect called Rowan's Law
- The law establishes removal-from-sport and return-to-sport protocols for players to
  ensure they are taken out of a game if they are suspected of having a concussion.
   Coaches and teachers will also be required to review online resources that help them
  identify and manage concussions in players.
- The bill also includes a concussion code of conduct that would set out rules of behaviour to minimize concussions while playing sports.
- The cost of baseline testing is \$80 and takes about 20-30 minutes.
- There is an app on the phone to allow coaches to report the concussion
