It requires that each member of the Bench Staff submit a Volunteer Criminal Record Check with his/her application. The cost is the responsibility of the individual. The London Ringette Association does not reimburse for Criminal Record Checks. Please be assured that these will be kept confidential, only those on the Coaching Committee will be reviewing them. The Volunteer Criminal Record Checks will be kept by the Coaching Committee. A check will be required every 3 years based on the date of issue by Police Services. At that time. Any existing copies will be shredded (hard copy) or deleted (digital copy) and replaced with the current copy. The London Ringette Association does not take responsibility for misdirected Police Checks. The individual Bench Staff/Volunteer is responsible for handing in a physical copy or digital copy to Coaching Committee Members.*

**Please Note the following:**

- Applicants being considered for a position may be contacted to attend an interview to be conducted by our Coaching Committee.
- In order to be registered with the Ontario Ringette Association you must now have or be able to attain the requisite qualifications for the position offered to you on or before January 8<sup>th</sup>, 2024. Copies of qualifications are required by the London Ringette Association.
- Due to the uncertainty of registration and resulting number of teams, the final selection of coaches for some levels may be delayed or deferred based on need. All applicants will be contacted if their application is being considered or not.
- The London Ringette Association reserves the right to solicit more applications if it deems necessary.
- Coaching is a great way to be involved in our community and to enhance your own professional development and leadership skills. Training to achieve the required coaching qualifications is reimbursed by the London Ringette Association.
