## **FUN 3 TIERING**

### **Preamble:**

1. Tiering will be 1st priority, geography will be second priority
2. Team placement can be adjusted for the second half of the season
3. Clubs may choose to tier or balance teams if they have multiple FUN 3 teams. If teams are balanced, they must be placed in the same tiering division for league play.
4. There will be NO crossover play between tiers - refer to point 1
5. A minimum of 6 teams are needed to create a loop
6. In order for the motion to pass,  $\frac{2}{3}$  majority is needed
7. If the motion passes, it will be subject to RO approval

**Motion: For the 2026–2027 season, the FUN3 division shall be organized into tiers based on each team’s self-assessed level of play. Wherever possible, teams of comparable skill level shall be grouped according to geographic proximity.**

## **NEW BUSINESS**

### **LORL Team Fees:**

- FUN2: \$150 (\$100 for teams starting in January)
- FUN3 to U19: \$200
- **Adult teams: \$50 - Change**

### **Year End Tournament**

- RO will NOT be running a U12 Event. This significantly increases the teams for our event.
- The package to Host will be sent out tomorrow. Deadline is June 30, 2026
- Ideally it will be held on one weekend with one club hosting or a couple co-hosting.
- Preferred dates: March 25-27 (Easter) OR April 2-4, 2027

### **Division Convenors**

- We will be asking for Division Convenors at our first general meeting in September. If you are interested or know somebody who would be good for this job, please reach out to the Divisions Director at [divisions@lorl.ca](mailto:divisions@lorl.ca).

### **Team Formation:**

- U14-U19 teams must be submitted to LORL by Sept. 14, 2026 and FUN 2 to U12 must be submitted by Sept. 21, 2026 so the schedule can be made. Please close registration and schedule ice with this date in mind if sorts need to be completed.

### **Ice Submission:**

- Ice submission and black out dates must be submitted by Sept. 14, 2026

### **Game Play:**

- U14-U19 games will start Oct. 3, 2026
- FUN 3 and U12 games will start Oct. 10, 2026
- FUN 2 will start Nov. 7, 2026

### **League Play:**

- U16 and up will have a schedule made for the entire season - no reseeding. This will happen at the year-end tournament. If the number of teams allows division based on geography it will occur, if not, all teams will play each other.
- For U14 and lower, LORL will be divided by geography (3 areas or 2 areas based on number of teams - 12A may be the exception) with reseeding in December.

**Blackout Dates:** Blackout dates are for tournaments only or other events at your home arena. Blackout dates will not be accepted for either end of March break or Family day weekend. This is what substitution requests are for.

**Mixed Ringette:** LORL will continue as a mixed league from Fun levels to U19. The following will still apply to U14 and up:

- 51% of skaters on the ice must identify as female, while goalies will be excluded from this calculation. Under this model, the maximum number of male skaters permitted during 5 v 5 play would be two and when playing short-handed it would be one.

### **Overaged Players:**

- Overage players MUST be approved by LORL. LORL will then send all requests to RO for final approval.
- Overage players may only be from one age group older and female - exceptions will only be made for very rare circumstances.

### **Underaged Players:**

- ALL requests for U14 and up will need to go through Ringette Ontario
- No approvals are needed for FUN 2- U12.

### **NEW RULE:**

#### ***Spectator Behaviour***

As a league, many of the complaints we had to deal with this year were not about players, but about the behaviour of adults. This is a trend across all sports and not just an issue with Ringette. As a result, we will be dealing with poor behaviour of adults very harshly. The volunteers at LORL cannot be at all games, so we will need the cooperation of Associations. The following process will be added to our rules:

1. **First offence** of poor spectator behaviour towards officials or players or in front of players will go to the association to deal with, on top of any other penalties administered by officials
2. **Second offence** will be a \$1000 fine to the team. Teams will not be able to play until the fine is paid in full
3. **Third offence**, the team will not be allowed to attend the LORL year-end event - if the third offence is a bench staff member, they will not be allowed on a TRF in any capacity in LORL for 3 years.

## **President's Report – Shelley Handley**

As I conclude my term as the inaugural President of LORL, I would like to take a moment to reflect on the past season and the growth of our league over its first two years.

Overall, this has been a successful season, with strong participation, continued development, and a commitment across all associations to providing meaningful opportunities for our athletes. That said, there remains important work ahead as we continue to grow and improve.

The most significant concern expressed by our membership continues to be player safety, both on and off the ice. This includes not only the physical well-being of players, but also the environment in which they compete. The behaviour of spectators toward players and officials has been raised repeatedly, and it is an area that requires ongoing attention, education, and accountability across all levels of our league.

Another ongoing area of discussion is the role of boys in ringette and how best to manage this evolving aspect of our sport. Ringette Canada has conducted national research examining perceptions and participation related to males in ringette; however, that report has not yet been shared publicly. In response, LORL will be undertaking its own research initiative in partnership with York University, with Wendy Stirbet serving as the league lead. This work will be critical in helping us make informed, thoughtful decisions moving forward.

We are also looking ahead to opportunities for growth, particularly in expanding our Adult League (18+ BB, B, CC, and C divisions). This represents an important pathway for lifelong participation in our sport and an area with strong potential for development.

This coming season, we are proud to introduce a regional-level scholarship program for all LORL players, continuing the legacy of Mary and Keith Kaiser from the former Western Region. This initiative reflects our commitment to supporting our athletes both within and beyond the sport.

I would also like to officially welcome Greater Sudbury to LORL. Their commitment to participating at the “B” level and the dedication shown by their players is commendable, and we are excited to have them as part of our league.

None of this would be possible without the incredible dedication of our Board of Directors. I extend my sincere thanks for their ongoing support, leadership, and the countless hours they have invested in ensuring the success of this league. Similarly, I want to acknowledge all Association Presidents for their hard work and commitment. It is not an easy role, and it often comes with challenges, but it is essential to the strength of our sport.

As the league’s first President, it has been an honour to help build the foundation of LORL. I firmly believe that we have established a strong and sustainable base, and I am confident that the league will continue to grow stronger and better in the years ahead.

As the season progressed, additional FUN2 teams joined, contributing to growth ahead of the mid-season reseeding for FUN3 and U12 divisions. 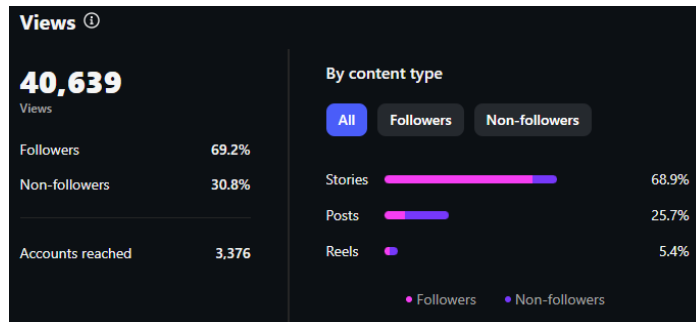

## LORL Communications Report – AGM 2026

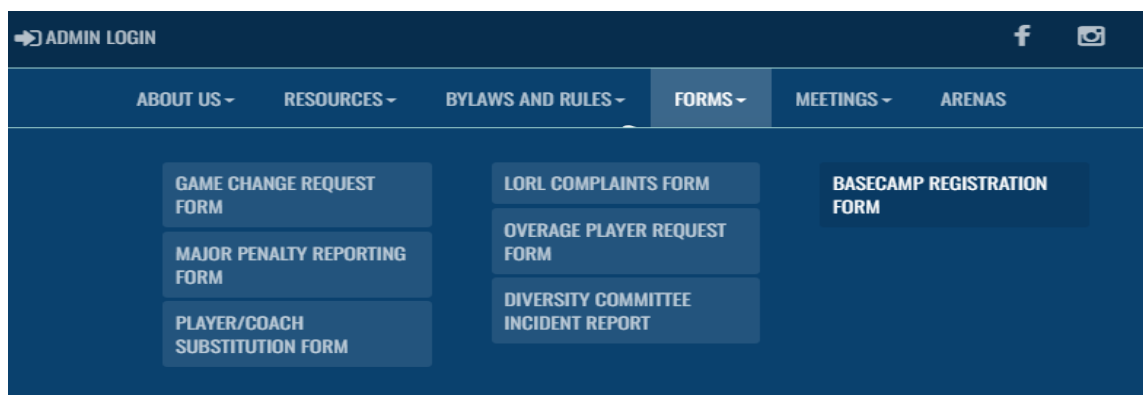
