## **PRIVACY POLICY AND CONSENT FORM**

### **Objective:**

To communicate the use of personal information within the Macklin Minor Hockey Association and provide a means to consent for the collection and use of that personal information in accordance with the operating needs of Macklin Minor Hockey Association.

### **Policy Statement:**

The Macklin Minor Hockey Association (“MMHA”) is subject to privacy legislation, Bill C 107, which covers the collection, use, retention and disclosure of our member’s personal information. The privacy legislation, both Federal and Provincial, were enacted to ensure that our member’s private and personal information is protected.

### **Policy Statement:**

The MMHA collects and uses personal information to contact our members, facilitate player placement, register players with the North Eastern Alberta Hockey League/Hiway 14 Hockey League, Hockey Canada and or Saskatchewan Hockey Association, keep records of our players’ team placements and our player personnel certification, training, and recruit volunteers.

The MMHA will be asking for your consent to collect, use, disclose and retain your personal information for administrative purposes. The Consent Form will explain what information we collect, how we use it and to whom it is disclosed.
