TO BE ELIGIBLE YOU MUST ALSO MEET THE FOLLOWING CRITERIA:

- ARE IN GOOD STANDING WITH THE MANITOBA SOCCER ASSOCIATION.
- ARE COMPLIANT WITH THE BY-LAWS, POLICIES AND DIRECTIVES OF THE MSA.
- ARE A GOOD CORPORATE CITIZEN.
 - ADHERES TO THE MSA AND CSA CODE OF CONDUCT.
- ADHERES TO THE LONG-TERM PLAYER DEVELOPMENT STAGE-APPROPRIATE PRINCIPLES.
- REGISTERS ALL PARTICIPANTS WITH THE MANITOBA SOCCER ASSOCIATION.
- DOES NOT INTERACT WITH NON-MEMBER ORGANIZATIONS WITHOUT THE APPROVAL OF THE MSA.

STEP TWO: GATHER ALL DOCUMENTS.

SUBMIT THE FOLLOWING DOCUMENTS WITH YOUR APPLICATION FORMS:

- DATABASE OF ALL YOUR ORGANIZATIONS COACHES THAT INCLUDE:
 - NCCP NUMBER, CURRENT LICENCE AND DATE OF CERTIFICATION, RIS, C/E-PIC, AND CARC.
- CLUB INFRASTRUCTURE FORM THAT INCLUDES ALL FACILITIES YOUR ORGANIZATION USES FOR THEIR PROGRAMS, BOTH OWNED AND RENTED.

- TECHNICAL DOCUMENTS THAT INCLUDE:
 - A DESCRIPTION OF YOUR ORGANIZATIONS PROGRAMMING FOR EACH LTPD STAGE OF DEVELOPMENT.
 - A LIST OF ALL LTPD AND NON LTPD COMPETITIONS EACH STAGE OF DEVELOPMENT CURRENTLY PARTICIPATES IN.
- ALL POLICIES REQUIRED: *PLEASE CLICK FOR SOME HELPFUL LINKS AND TEMPLATES.*
