After this first year, a player movement form is required if they choose to move homes Registration for the upcoming season to run from June 15, 2025 to July 15, 2025 Returning players that register outside of this date will incur a late fee of \$100. Riva Low makes a motion to run registration from June 15, 2025 to July 15, 2025. A minimum \$100.00 deposit is required at the time of registration, with fees to be paid in full by July 15, 2025 (unless payment arrangements are made prior to July 15, 2025). Returning players that are registered outside of the set registration dates will incur a \$100.00 late registration fee. All in favor.
