

Metcalfe & District Ringette Association Call for Nominations of Candidates for the Board of Directors To stand for election at the Annual General Meeting, June 7th, 2022

The Recruitment Committee of MDRA is issuing this Call for Candidates, to stand for election to the Board of Directors of MDRA at the Annual General Meeting to be held June 7th, 2022.

Positions to be filled:

• 5 Directors (1 x 1 year term, 4 x 3 year terms)

At this time, MDRA is placing particular emphasis on candidates with the following skills:

- Social media/public relations/channel management
- Technology/information systems
- Website management/graphic design
- Records/data management

Candidates with other competencies are welcome to apply.

MDRA would like to ensure the association is accurately represented across all age groups and levels of play. We strongly and enthusiastically encourage candidates who are currently involved in regional level play and age groups U12 and under to put forward their candidacy.

Selection of Officers

Following the Annual General Meeting, the board will hold its first meeting to vote on the appointments of Required Officers. These appointments will be made based on fit by matching skill-set to the duties of each officer position.

The following Officer position are open for appointment:

- 1. President
- 2. Vice-President, Player Development
- 3. Vice-President, Coaching
- 4. Treasurer
- 5. Director of Board Operations

In addition to these officer positions the Board of Directors will also be appointing the following roles:

- 1. Director of Competitive
- 2. Registrar
- 3. Equipment Director
- 4. Ice-scheduler
- 5. Webmaster
- 6. Special Events Coordinator
- 7. Statistician
- 8. Referee-in-Chief
- 9. Fundamentals Coordinator

Eligibility

To be eligible to serve as a Director, an individual must:

- 1. Be eighteen (18) years of age or older;
- 2. Have not been declared incapable by a court in Ontario;
- 3. Not have the status of bankrupt; and
- 4. Meet all Ringette Ontario requirements that generally apply to directors and members or local ringette associations.

Nominations

All nominations of an individual for election as a Director must:

- a. Be nominated by an MDRA member in good standing and sent to any member of the Recruitment Committee;
- b. Complete and submit the Candidate Profile form no later than June 4th, 2022;
- c. Review following documents prior to submitting the Candidate profile form:
 - i. Call for Nominations Candidate Document
 - ii. MDRA By-laws.

To ensure that there are sufficient well-qualified candidates for consideration by the membership, the Recruitment Committee may seek out and nominate candidates in addition to those nominated by the membership.

A candidate's nomination by the Recruitment Committee merely puts forward that candidate's name for election by the MDRA membership at the Annual General Meeting. It does not represent an endorsement of the candidate.

The Recruitment Committee will present all nominees at the Annual General Meeting.
